WHEREAS, the recognition was granted to the institution namely Sakthi Institute of Teacher Education and Research, 1014/4A, Sakthi Nagar, Dindigul - Palani Main road, Palakkanuthu (PO), Dindigul (DT) - 624619, Tamil Nadu run by Sowdamman Charitable Trust, 216, 4A, Thiruvalluvar Salai, Oddanchatram - 624619 Tamil Nadu on dt. 05.10.2006 for conducting M.Ed. course of one-year duration with an annual intake of 25 students.

AND WHEREAS, the enhancement of intake from existing 25 to 35 was permitted to the institution vide NCTE's order dt 23.08.2010.

AND WHEREAS, the institution has submitted an affidavit dt 20.01.2015 for adherence of new Regulations, 2014.

AND WHEREAS, the Revised Provisional Recognition Order was issued to the institution on 22.05.2015 for conducting two-years M.Ed course of 50 students for 2015-16 academic session.

AND WHEREAS, the matter was placed before the SRC in its 386th meeting held on 23<sup>rd</sup> – 24<sup>th</sup> July 2020. The Committee considered the matter and decided to issue Final Show Cause Notice was issued to the institution on 30.07.2020. The institution has submitted its reply on 01.09.2020.

AND WHEREAS, the matter was finally considered by the SRC in its 389th Virtual Meeting held from 12th & 14th October 2020 decided as under: -

> "The institution was issued a Final Show Cause Notice (FSCN) dated 30.07.2020. The institution has submitted its reply on 01.09.2020. The Committee observed the reply submitted by the institution and found the following deficiencies.

- 1. The institution has not submitted original blue prints of Building Plan. The building plan submitted by the institution is not readable.
- 2. The institution has not submitted notarized English version of NEC duly approved by the competent authority.
- 3. Dr. A. Ramakrishnan, Principal was approved at this designation till 01.08.2020. The tenure of the principal is already expired as per approval letter dt 08.08.2019 of the TNTEU. The faculty namely S. Meena, J. Antony Lisa are not qualified as their appointment date is 20.06.2017. (As NET qualification is compulsory as amended in NCTE vide notification dt. 09.06.2017).
- 4. The institution has not submitted faculty for B.Ed course.
- 5. The institution has not submitted details of website.
- 6 The institution has not submitted Site Plan duly approved by the competent

Hence, the Committee decided to withdraw the recognition granted to Sakthi Institute of Teacher Education and Research, Sakthi Nagar, Palakkanuthu, Dindigul District-624624, Tamilnadu for conducting B.Ed & M.Ed courses w.e.f. the 2020-21 academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.."

NOW THEREFORE, in exercise of the powers vested u/s 17 of 1993 of NCTE Regulations the institution namely Sakthi Institute of Teacher Education and Research, 1014/4A, Sakthi Nagar, Dindigul — Palani Main road, Palakkanuthu (PO), Dindigul (DT) — 624619, Tamil Nadu run by Sowdamman Charitable Trust, 216, 4A, Thiruvalluvar Salai, Oddanchatram — 624619 Tamil Nadu, is hereby withdrawn for conducting M.Ed programme of two years duration with an annual intake of 50 students on the grounds mentioned above. The withdrawal of recognition is effective from the academic session commences next to issuance of this order.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order Withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purposes of employment under the Central Government, any State Government or University, or in any School, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal u/s 18 of the NCTE Act, 1993, through "online mode" available on NCTE's website <a href="https://www.ncte-india.org">www.ncte-india.org</a>, with 60 days from the date of issue of this order. The guidelines for filling appeal may be seen on NCTE's website.
