WHEREAS, the recognition was granted to University college of Physical Education, Gnana Ganga, Gulbarga University, Gulbarga-58106, Karnataka for B.P.Ed. course vide order dt. 05.03.2002 for conducting Secondary (B.P.Ed.) course of one-year duration with an annual intake of 50 students.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dt. 16.01.2015 for its willingness of two units in B.Ed. course and adherence of provisions of new Regulations.

AND WHEREAS, provisional revised recognition order was issued to the institution on 29.05.2015 for conducting B.P.Ed. course of two years duration with an annual intake of 100 (two section of 50 each) from the academic session 2015-16.

AND WHEREAS, a Show Cause Notices dt 16.10.2020 was issued for submissions of certain documents as decided by the SRC in the 375th Meeting of SRC. The institution has not submitted any reply in respect to the Show Cause Notice.

AND WHEREAS, the SRC in its 388th Meeting held on 14th to 15th September 2020 considered the matter and decided to issue Final Show Cause Notice to all such institutions which have not submitted its reply to Show Cause Notice. Accordingly, Final Show Cause Notice was issued on 16.10,2020.

AND WHEREAS, the institution has not submitted any reply to both Show Cause Notices till date.

AND WHEREAS; the SRC in its 393rd meeting held on 05th & 06th January 2021 and considered the matter as under: -

The original files of the Institution along with other related documents, NCTE Act, 1993. Regulations Guidelines issued by NCTE from time to time and documents

furnished by the institution were carefully considered by the SRC and the following observations were made: =

1. The institution has not responded to the Final Show Cause Notice issued on 16.10.2020.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order Withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purposes of employment under the Central Government, any State Government or University, or in any School, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal u/s 18 of the NCTE Act, 1993, through "online mode" available on NCTE's website was noted india or with 60 days from the date of issue of this order. The guidelines for filling appeal may be seen on NCTE's website.
