WHEREAS The recognition was granted to Sri Jagadguru Balagangadharanatha Swamiji College of Physical Education, S.B.J.S. Campus (SJCIT), Chickballapur 562101, Kolar District, Karnataka for B.P.Ed. course vide order dt. 04.08.2005 for conducting (B.P.Ed.) course of one-year duration with an annual intake of 50 (Fifty) students.

and whereas, after the promulgation of NCTE Regulations, 2014 affidavit submitted on dt. 21.01.2015 by the institution, the provisional revised recognition order was issued to the institution on dt. 20.05.2015 for conducting **B.P.Ed. course of two years duration with an annual intake** of 100 students (two sections of 50 students each) from the academic session 2015-16.

AND WHEREAS, a Show Cause Notice dt. 16.05.2019 was issued for submission of certain documents as decided to the SRC in its 375^{th} Meeting of SRC held on 13^{th} – 14^{th} May 2019.

AND WHEREAS The institution has not submitted any reply in respect to the show cause notice issued on 16.05.2019.

AND WHEREAS, the matter of such institution were placed before the SRC in its 388^{th} meeting held on 14^{th} – 15^{th} September 2020. The Committee decided that a Final Show Cause Notice be issued to the such institutions which have not submitted any representation to the Show Cause Notice.

AND WHEREAS, a Final Show Cause Notice was issued to the institution on 16.10.2020.

AND WHEREAS, the SRC in its 393rd Meeting held on 05th & 06th January 2021 and considered the matter as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

1. The institution has not responded to the Final Show Cause Notice issued on 16.10.2020."

NOW THEREFORE, the Committee decided to withdraw the recognition granted to Sri Jagadguru Balagangadharanatha Swamiji College of Physical Education, S.B.J.S. Campus (SJCIT), Chickballapur 562101, Kolar District, Karnataka for conducting B.P.Ed course w.e.f. the next academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order Withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purposes of employment under the Central Government, any State Government or University, or in any School, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal u/s 18 of the NCTE Act, 1993, through "online mode" available on NCTE's website www.ncte-india.org, with 60 days from the date of issue of this order. The guidelines for filling appeal may be seen on NCTE's website.
