### **ORDER**

WHEREAS, the institution Kalaiammal College of Education, No. 6, Anna Salai, New Bus Stand Backside, Karur, Tamilnadu-639002 was granted recognition vide SRC (NCTE) order no. F.TN/SEC/SRO/NCTE/2005-2006/4062 dt. 17.11.2005 for conducting B.Ed. course of one-year duration with an annual intake of 100 students from the academic session 2005-2006.

AND WHEREAS, the SRC in its 203<sup>rd</sup> meeting held on 31<sup>st</sup> March & 01<sup>st</sup> April 2011 considered the VT report of the institution and other related documents along with the original file of the institution for shifting to new/permanent premises from No. 6, Anna Salai, New Bus Stand Backside, Karur, Tamilnadu-639002 to the new address S. F. No. 305/1, Pavithiram Village and Post, Aravakauruchi Taluk, Karur, Tamilnadu-639002 and decided to permit shifting at new premises under intimation to the university.

AND WHEREAS, after the promulgation of NCTE Regulations, 2014 and as per affidavits submitted by the institution dt. 24.01.2015 the provisional revised recognition order was issued to the institution on 26.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (two units) from the academic session 2015-16

AND WHEREAS, the institution submitted compliance against RPRO issued in respect of B.Ed. course vide letter dt. 03.11.2015 the matter was placed before in 314<sup>th</sup> meeting of SRC held on 27<sup>th</sup> & 28<sup>th</sup> May 2016 wherein a general decision was taken to cause inspection of such cases

**AND WHEREAS**, as per the decision of SRC, a letter for inspection was sent on 14.06.2016, but inspection was not conducted.

**AND WHEREAS.** on the basis of decision taken by the SRC in its 369<sup>th</sup> meeting held on 28.01,2019, a Show Cause Notice was issued to the institution on dt. 16.09,2019 with the direction to submit compliance of RPRO for B.Ed. course.

AND WHEREAS, the institution submitted its reply along with documents on 18.10.2016 in compliance of Show Cause Notice dt. 16.09. 2019. The detail of documents / information submitted by the institution in compliance of Show Cause Notice dt. 04.10.2019. The above reply was placed before the SRC in its 382<sup>nd</sup> meeting held on 26-27 November 2019. The Committee decided to issue Final Show Cause Notice. Accordingly, a Final Show Cause Notice was issued on 31.12.2019. The institution has not submitted its reply till date.

**AND WHEREAS**, SRC in its 386<sup>th</sup> meeting held on 23<sup>rd</sup> to 24<sup>th</sup> July 2020 considered the matter and decided to issue withdrawal order to the institution. Accordingly, Withdrawal order was issued on 17.08,2020.

AND WHEREAS, the institution preferred an appeal u/s 18 of NCTE Act, 1993 and the Appellate Authority vide order No. 89-224/E-167302/2020 Appeal/29<sup>th</sup> Mtg.-2020/2<sup>nd</sup> December 2020/95595 dt. 16.12.2020 remands back the case. The operative part of the order is as under:-

AND WHEREAS, Appeal Committee noted that after getting the S.C.N. dated 31.12.2019 appellant institution ought the have replied to the S.C.N. by resubmitting the required documents with latest approved list, Non-Encumbrance Certificate and FDRs etc. Appellant, of late, has submitted with its appeal memoranda copies of (i) List of faculties approved by TNTEU, (ii) Non-Encumbrance Certificate (English Translation), (iii) FDRs, (iv) Certificate Copy of land documents, (v) Land Use Certificate, (vi) Building Plan, (Vii) Building Completion Certificate. Appellant institution is required to submit original and zerox copies of the required documents to SRC within 15 days of the issue of appeal order. Appeal Committee further decided to remand back the case to SRC for revisiting the matter after the appellant institution has submitted copied of the required documents.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and arguments advanced during the online submission, Appeal Committee concluded to remand back the case to SRC for revisiting the matter.

NOW THEREFORE, the Council hereby remands back the case of Kalaiammal College of Education, Pavithram, Aravakurichi, Karur, Tamil Nadu to the SRC, NCTE, for necessary action as indicated above.

**AND WHEREAS,** the institution has submitted a reply dt. 04.12.2020 for FSCN for B.Ed. along with the documents, and the matter was considered by the SRC in its 393<sup>rd</sup> meeting held on 05<sup>th</sup> -06 January 2021 as under: -

"The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

On the perusal of the reply submitted by the institution the Committee decided that the continuation order be issued to the Institution Kalaiammal College of Education, No. 6, Anna Salai, New Bus Stand Backside, Karur, Tamilnadu-639002 for the following courses: -

B.Ed. - 2 units (50 students each unit)

Now therefore, the SRC decided to permit the institution i.e. Kalaiammal College of Education, No. 6, Anna Salai, New Bus Stand Backside, Karur, Tamilnadu-639002 for

B.Ed. course run by Thirumathi Kaliammal Palaniappan Educational Charitable Trust for continuation of recognition for B.Ed. course of two years duration with an annual intake of 100 students (two basic units) subject to fulfilment of the following conditions:

- 1. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- 11. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations. 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- V. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 12. Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc. as applicable.
- 13. The institution shall submit to the Regional Committee a Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned.

The information with regard to the following shall also be made available on the website namely: -

- a. Sanctioned programme(s) along with annual intake in the institution:
- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c. Name of faculty members who left of joined during the last, quarter:

- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
- e. Fee charged from students.
- f. Available infrastructural facilities.
- g. Facilities added during the last quarter.
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information, if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 15. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 16. The institution shall make available the list of students admitted on its official website.
- 17. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act. Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the

Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
