WHEREAS, the recognition u/s 14(3)(a) of NCTE Act, 1993 was granted to the institution namely Sri Lakshmi B.P.Ed. College, Dupadu Village, Kallur Taluk, Kurnool Districty, Andhra Pradesh run by Vaibhav Educational Society, Sreenivasa Nagar Road, Allagadda Village, Post and Taluk, Kurnool District-518543, Andhra Pradesh vide order No. F. SRCAPP2033/B.P.Ed./AP/2014-15/56500 dated 29.01.2014 for conducting B.P.Ed. programme of one-year duration with an annual intake of 100 students from the academic session 2014-15.

- 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution submitted affidavit dated 25.06.2015 for its willingness & adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 01.07.2015 for conducting B.P.Ed. Programme of two years duration with an annual intake of 100 students from the academic session 2015-16.
- 3. AND WHEREAS, the SRC in its 306th meeting held on 01st to 04th March 2016 considered the matter and decided to permitted shifting to new location. Accordingly, as per the decision of SRC, an Order No.F.SRO/SRCAPP2033/B.P.Ed./AP/2016/82683 dated 16.03.2016 was issued to the new location at Sri Lakshmi B.P.Ed. College, Dupadu Village, Kallur Taluk, Kurnool District, Andhra Pradesh.
- 4. AND WHEREAS, the SRC in its 422nd meeting held on 02nd 03rd March 2023 considered the matter and decided to issue a Show Cause Notice. Accordingly, as per the decision of SRC, a Show Cause Notice was issued to the institution on 22.03.2023. The institution vide dated 06.04.2023 has submitted a reply to the Show Cause Notice.
- 5. AND WHEREAS, the SRC in its 423rd meeting held on 12th April 2023 considered the matter and committee decided to issue Final Show Cause Notice. Accordingly, as per the decision of SRC a Final Show Cause Notice was issued to the institution on 21.04.2023.(page No 1163). The institution has submitted reply of Final Show Cause Notice vide letter dated 09.05.2023.
- 6. AND WHEREAS, the SRC in its 425th meeting held on 18th May 2023 considered the matter and decided as under:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Sri Lakshmi B.P.Ed. College, Survey No. 62/2, 61,52/B2, Dupadu Village, Kallur Mandal, Kurnool District, Andhra Pradesh for B.P.Ed. programme for 1 basic unit of 100 students."

Pradesh for continuation of recognition for B.P.Ed. Programme for two-years duration with an annual intake of one unit of 100 students subject to fulfilment of the following conditions:-

- The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 8. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- 9. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 10. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned.
