WHEREAS, the recognition was granted to the institution namely, Rasama College of Education, Vettamangalam Village & Post, Palhakaliamman Nagar, Karur District, Tamilnadu-639117 run by K.K.V.P. Rasammal Educational Trust, Karur District, Tamilandu vide SRC vide order no. F.SRO/NCTE/M.Ed./2007-2008/1513 dt. 06.05.2008 for conducting M.Ed. course of one year duration with an annual intake of 25.

- 2. AND WHEREAS, the enhancement of intake of 10 seats from existing 25 to 35 is permitted to Rasama College of Education, Vettamangalam Village & Post, Palhakaliamman Nagar, Karur District, Tamilnadu-639117 vide order No. F.SRO/NCTE/2010-2011/20681 dt. 25.08.2010 from the session 2010-2011.
- 3. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dated 28.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 22.05.2015 for conducting M.Ed. programme of two years duration with an annual intake of 50 students for one basic unit from the academic session 2015-16.
- 4. **AND WHEREAS,** the SRC in its 388th meeting held on 14th 15th September, 2020 considered the matter and decided to issue SCN/FSCN in all RPRO cases asking them to submit all the required documents as per the 13 points. Accordingly, as per decision of SRC a Show Cause Notice was issued to the institution on 24.02.2022. The institution has submitted reply on 23.03.2022.
- **5. AND WHEREAS**, the SRC in its 409^{th} Meeting held on $29^{th} 30^{th}$ March, 2022 considered the matter and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Rasama College of Education, Survey No. 1211/3, 1211/4, PaathakaliammanNagar, Vettamangalam Village Panchayat, Karur Taluk & Distict-639117 Tamilnadu for M.Ed. programme for 1 basic unit of 50 students subject to the condition of submission of Bank Statements showing the disbursement of salary through bank account to all individual faculty (at-least for last 1 year) as required under clause 10(2) of NCTE Regulations, 2014. RD, SRC is advised to issue order only after obtaining the bank statements."

6. AND WHEREAS, as per decision of SRC a letter was issued to the institution on 12.04.2022. The institution has submitted bank statement vide letter dated 04.05.2022 according, to statement the salary is being disbursed through bank.

- 7. NOW THEREFORE, this order is issued permitting the institution i.e., Rasama College of Education, Survey No. 1211/3, 1211/4, PaathakaliammanNagar, Vettamangalam Village Panchayat, Karur Taluk & Distict-639117 Tamilnadu run by K.K.V.P. Rasammal Educational Trust, Survey No. 1211/3, 1211/4, Paathakaliamman Nagar, Vettamangalam Village Panchayat, Karur Taluk & District, Tamilnadu-639117 for Continuation of recognition for M.Ed. programme for two years duration with an annual intake of 1 basic unit of 50 students subject to fulfilment of the following conditions: -
 - I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
 - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
 - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
