- AND WHEREAS, the SRC in its 366th meeting held on 03rd & 04th December 2018 considered the matter and decided to issue Show Cause Notice. Accordingly, as per the decision of SRC, a Show Cause Notice was issued to the institution on 18.12.2018. The institution has submitted reply on 20.10.2020.
- AND WHEREAS, the SRC in its 404th meeting held on 16th & 17th November 2021 has 3. . considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per the decision of SRC, a Final Show Cause Notice was issued to the institution on 30.11.2021. The institution has submitted reply on 25.04.2022.
- AND WHEREAS, the SRC in its 410th Meeting held on 25th & 26th April, 2022 considered the matter and decided as under: --

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Sri Venkateswara College of Education, Survey No. 315/1G, 316/2F, Parasur Village & Post, Cheyyar Taluk & City, Tiruvannamalai District-604409, TamilNadu for M.Ed. programme for 1 basic unit of 50 students subject to the condition on submission of Bank Statements showing the disbursement of salary through bank account to individual faculty members (at-least for last 1 year) as required under clause 10(2) of NCTE Regulations, 2014. RD, SRC is advised to issue order only after obtaining the bank statements.

- AND WHEREAS, as per decision of SRC a letter was issued to the institution on 10.05.2022. The institution has submitted bank statement vide letter dated 10.05.2022 according, to statement the salary is being disbursed through bank.

Educational Trust, Survey No. 315/1G, 316/2F, Parasur Village & Post, Cheyyar Taluk & City, Tiruvannamalai District-604409, TamilNadu for Continuation of recognition for M.Ed. programme for two years duration with an annual intake of 1 basic unit of 50 students subject to fulfilment of the following conditions: -

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 7. Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- 8. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 9. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned.  - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
