WHEREAS, permission u/s14 Act of NCTE, 1993 was granted to the institution namely, KSR & KRK College of Education, H.No.22-16-6, Deshodharaka Veedhi, Kothapet, Tenali-522201, Guntur District, Andhra Pradesh run by Potti Sriramulu Educational Society, Andhra Guntur District. Pradesh vide SRC (NCTE) no.F.SRO/NCTE/B.Ed./2005-2006/5127 dt.06.01.2006 for conducting Secondary B.Ed. Course of one year duration with an annual intake of 100 students from the academic session 2005-2006.

- AND WHEREAS, after promulgation of NCTE Regulations, 2014, the institution had 2. consented to come under new Regulations vide a notarized affidavit dated 21.01.2015. A revised provisional recognition order was issued on 19.05.2015 to the institution for conducting B.Ed. programme of two years duration with an annual intake of 100 students (two basic units) from the academic session 2015-16.
- AND WHEREAS, the SRC in its 381st meeting held on 31st Oct & 01st Nov, 2019 has considered the matter and the decided to issue SCN in all such matters where the institution has not submitted the requisite documents/VT report not accompanied with the requisite documents in response to RPRO issued by the SRC. Accordingly, as per the decision of SRC, a First Show Cause Notice was issued to the institution on 13.11.2019. The institution did not submit reply to the First Show Cause Notice.
- AND WHEREAS, the SRC in its 408th meeting held on 02nd March 2022 has considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per the decision of SRC, a Final Show Cause Notice was issued to the institution on 14.03.2022. The institution has submitted reply on 19.04.2022.
- AND WHEREAS, the SRC in its 410th Meeting of SRC held on 25th 26th April 2022 considered the reply to Final Show Cause Notice and decided as under: -

"The original files of the Institution along with other related documents, NCTE Act, 1993. Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The institution was issued a Final Show Cause Notice (FSCN). The institution has submitted its reply vide dated 09.04.2022. The Committee observed the reply submitted by the institution and found the following deficiencies.

1. The building plan submitted by the institution is neither approved nor legible.

2. The following faculty was appointed after notification (dt. 09.06.2017) of NCTE (Amendment) Regulations, 2014 and are not qualified as not possessing NET qualification:

- 3. The website of the institution is not uploaded with the information required under clauses 7(14)(i), 8(14) and 10(3) of NCTE Regulations, 2014.
- 4. The institution did not submit proof of disbursement of salary to faculty & non-teaching staff through bank account as required under clause 10(2) of NCTE Regulations, 2014.
- 5. The institution did not submit registration certificate and bye laws of the managing society / trust.

Hence the recognition granted to KSR & KRK College of Education, H. No. 22-16-6, Deshodharaka Veedhi, Kothapet, Tenali, Guntur District, Andhra Pradesh-522201 for B.Ed. course is withdrawn under Section 17(1) of NCTE Act, 1993 from the next academic session i.e. 2022-2023. On withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body from the next academic session stands withdrawn. Hence, the institution is not entitled to participate in counseling / making admissions from the academic session i.e. 2022-2023".

- 6. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to KSR & KRK College of Education, H. No. 22-16-6, Deshodharaka Veedhi, Kothapet, Tenali, Guntur District, Andhra Pradesh-522201 run by Potti Sriramulu Educational Society, Tenali, Guntur District, Andhra Pradesh for conducting B.Ed. Programme of two years duration with an annual intake of 100 students (2 basic units) with effect from the academic session i.e., 2022-2023 onwards. Further, on withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body from the academic session stands withdrawn. Hence, the institution is not entitled to participate counselling from the academic session i.e., 2022-2023 and the institution is also not permitted to take any fresh admission of students from the academic session 2022-2023.
- 7. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

8. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
