WHEREAS, recognition u/s 14 Act of NCTE, 1993 was granted to the institution namely, M.R.R. College of Education, Near D.S.P Office, Nandigama, Krishna District, Andhra Pradesh-521185 run by Andhra Pradesh Girijana Sevak Sangha, Krishna District, Andhra Pradesh vide order no. F.SRO/NCTE/B.Ed./2010/20060 dt. 28.07.2010 for conducting B.Ed. course of one-year duration with an annual intake of 100 students from the academic session 2010-2011.

- AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dated 16.02.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 18.03.2015 for conducting B.Ed. programme of two years duration with an annual intake of 100 students for two basic units from the academic session 2015-16.
- AND WHEREAS, the SRC in its 314th meeting held on 27th to 28th May 2016, decided to conduct inspection of the institution. Accordingly, as per decision of SRC Inspection intimation was sent to the institution on 14.06.2016. The institution submitted original DD of Rs 1.50.000/- bearing No. 457664 dated 12.09.2016. received on 15.09.2016.
- AND WHEREAS, the institution has submitted representation on 08.11.2016. 4.
- AND WHEREAS, a letter received from the NCTE Hqrs on 01.12.2016 regarding implementation of NCTE Regulations 2014 in respect of two year Courses (B.Ed., M.Ed., and B.P.Ed). The matter was placed before the SRC in its 324th meeting held on 07th - 08th December 2016 and the committee considered and decided as under:
 - Noted.
 - 2.1. There will now be no more 'inspection' in RPRO cases to verify the built-
 - 2.2. We must collect latest Building Plan and latest Building Completion Certificate and proceed on that basis."
- AND WHEREAS, the institution submitted its representation on 27.03.2017 along with BP, BCC, Faculty List and Photocopy of FDRs.
- AND WHEREAS, a letter received from NCTE (Hqrs) on 10.04.2017 forwarding institution's the letter. The SRC in its 339th meeting held on 22nd - 23rd May, 2017 considered the matter and decided to issue Show Cause Notice. Accordingly, as per the decision of SRC Show Cause Notice was issued to the institution on 07.06.2017. The institution vide letter dated 19.06.2017 submitted its reply to the Show Cause Notice.
- AND WHEREAS, the SRC in its 381st meeting held on 31st Oct 01st Nov. 2019 considered the matter and decided to issue SCN in all such matters where the institution has not submitted the requisite documents/VT report accompanied with the requisite documents in response to RPRO issued by the SRC. Accordingly, as per the decision of SRC a Final

Show Cause Notice was issued to the institution on 13.11.2019. The institution has submitted reply on 09.12.2019.

9. AND WHEREAS, the SRC in its 410th Meeting held on 25th & 26th April, 2022 considered the matter and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The institution was issued a Final Show Cause Notice (FSCN). The institution has submitted its reply vide letter dated 09.12.2019. The Committee observed the reply submitted by the institution and found the following deficiencies.

- 1. The institution submitted a proforma of 16 faculty for B.Ed. and 10 for M.Ed. but the date of approval is not mentioned by the Registrar, Krishna University.
- 2. Two professors and two Associate Professors for M.Ed. Course have not been appointed as required under Appendix 5 of NCTE Regulations 2014.
- 3. BCC submitted is not under prescribed format.
- 4. Building plan submitted is neither approved nor legible.
- 5. Form 'A' issued by the concerned bank for FDRs towards Endowment Fund and reserve fund not submitted and both FDRs are matured.
- 6. NEC and LUC not submitted.
- 7. The website of the institution is not uploaded with the information required under clauses 7(14)(i), 8(14) and 10(3) of NCTE Regulations, 2014.
- 8. The institution did not submit proof of disbursement of salary to faculty & non-teaching staff through bank account as required under clause 10(2) of NCTE Regulations, 2014.
- 9. The institution did not submit registration certificate and bye laws of the managing society / trust.

Hence, the recognition granted to M.R.R College of Education, Near D.S.P Office, Nandigama, Krishna District-521185, Andhra Pradesh for both B.Ed. & M.Ed. courses are withdrawn under Section 17(1) of NCTE Act, 1993 from the next academic session i.e., 2022-2023. On withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body from the next academic session stands withdrawn. Hence, the institution is not entitled to participate in counselling / making admissions from the next academic session i.e., 2022-2023."

10. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to M.R.R College of Education, Near D.S.P Office, Nandigama, Krishna District-521185, Andhra Pradesh for conducting B.Ed. programme of two years duration with an annual intake of 100 students (2 basic units) with effect from the academic session i.e., 2022-2023 onwards. Further, on withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body from the academic session stands withdrawn. Hence, the institution is not entitled to participate counselling from the academic session i.e., 2022-2023 and the institution is also not permitted to take any fresh admission of students from the academic session 2022-2023.

11. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

12. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
