ORDER

In exercise of the powers vested under Section 14(3)(a) of the National Council For Teacher Education (NCTE) Act. 1993, the Southern Regional Committee grants recognition to Nehru Memorial Ex-servicemen Educational Society, Luthergiri, ITI Campus, Rajahmundry - 533 105, E.G. Dt., Andhra Pradesh for B.Ed Course of One year duration from the academic session 2000-2001 with an annual intake of 100, subject to fulfilling the following conditions:

- Construction of the building should be completed within one year.
- 2. The institution and the University shall ensure that the total number of teaching days including practice teaching as prescribed in the NCTE norms for the course should be scrupulously adhered to for the students admitted for the academic session 1999-2000.
- 3. Teaching days including practice teaching should not be less than the number fixed in the NCTE norms for the course from the academic session 2000-2001 onwards.
- 4. The institution shall function with **10** teaching staff in addition to Principal, Lecturer for Physical Education and other supporting staff possessing the qualifications as laid down in the NCTE norms and in the salary structure prescribed by the UGC/Central Government/State Government as the case may be.
- 5. The institution shall ensure library, laboratories and other instructional infrastructure as per the NCTE norms.
- 6. The admission to the approved course shall be given only to those candidates who are eligible as per the regulations governing the course and in the manner laid down by the affiliating University / State Government.
- Tuition fee and other fees will be charged from the students as per the norms of the affiliating University / State Government till such time NCTE regulations in respect of fee structure come into force.
- 8. Curriculum transaction, including practical work / activities, should be organised as per the norms and standards for the course and the requirements of the affiliating University / examining body.

- The institution if unaided, shall maintain endowment and reserve fund as per NCTE norms.
- The institution shall continue to fulfil the norms laid down under the regulations of the NCTE and submit to the Regional Committee the Annual Report and the Performance Appraisal Report at the end of each academic year. The performance appraisal report should inter alia give the extent of compliance of the conditions indicated above.

If Nehru Memorial Ex-servicemen Educational Society, Luthergiri, ITI Campus, Rajahmundry - 533 105, E.G. Dt., Andhra Pradesh contravenes any of the provisions of the NCTE Act or the rules regulations and orders made or issued thereunder or fails to fulfill the above conditions, the Regional Committee may withdraw this recognition under the provisions of Section 17(1) of the NCTE Act.
