In exercise of the powers vested under Section 14(3)(a) of the National Council For Teacher Education (NCTE) Act, 1993, the Southern Regional Committee grants recognition to SGB Government Institute of Advanced Study in Education, Opp.Saikrishna Theatre, Innespeta, Rajahmundry-533101, Andhra Pradesh for B.Ed Course of One year duration from the academic session 2000-2001 with an annual intake of 137, subject to fulfilling the following conditions:

- The institution shall appoint within a period of one year <u>five</u> additional teaching staff
 possessing the academic qualifications as laid down in the NCTE norms, in the salery
 structure prescribed by the UGC/Central Government/State Government as the case may
 be.
- Library Asst and Technical Asst. should be appointed.
- instructors for Work Experience and Art & Music should be appointed.
- The institution shall ensure library, laboratories and other instructional infrastructure as per the NCTE norms.
- The admission to the approved course shall be given only to those candidates who are eligible as per the regulations governing the course and in the manner laid down by the affiliating University / State Government.
- Tuition fee and other fees will be charged from the students as per the norms of the affiliating University / State Government till such time NCTE regulations in respect of fee structure come into force.
- Curriculum transaction, including practical work / activities, should be organised as per the norms and standards for the course and the requirements of the affiliating University / examining body.
- Teaching days including practice teaching should not be less than the number fixed in the NCTE norms for the course.
- The institution, if unaided, shall maintain endowment and reserve fund as per NCTE norms.

The institution shall continue to fulfil the norms laid down under the regulations of the NCTE and submit to the Regional Committee the Annual Report and the Performance Appraisal Report at the end of each academic year. The performance appraisal report should inter alia give the extent of compliance of the conditions indicated above.

If SGS Government Institute of Advanced Study in Education, Opp.Saikrishna Theatre, Innespeta, Rajahmundry-533101, Andhra Pradesh contravenes the provisions of the NCTE Act or the rules, regulations and orders made or issued thereunder or fails to fulfill the above conditions, the Regional Committee may withdraw this recognition under the provisions of Section 17(1) of the NCTE Act.

In exercise of the authority vested under the NCTE Act, the Southern Regional Committee after considering your application for grant of recognition, decided to accord One Year provisional recognition to Sri Garimella Satyanarayana IASE, Rajhamundry, Andhra Pradesh to Secondary course with duration of one year for the year 1997-98.

The provisional recognition accorded is subject to setting right the following deficiencies:

- Accommodation to Seminar hall, Work Experience lab, Computer lab, Language lab, Social Science lab and Library should be provided.
- Equipment for Science lab should be provided.
- Principal's post and 5 vacant posts of lecturers should be filled up immediately and also the staff for Work Experience, Library, Technical Assistant should be provided.
- Teacher pupil ratio works out to 1:32. Since there are only 5 staff members, action should be taken to maintain the ratio at 1:10.

The institution should send a **Compliance Report** for setting right the above deficiencies to the Regional Committee by **31.01.1998**.
