CONTINUATION ORDER

WHEREAS, recognition u/s14 NCTE Act, 1993 was granted to the institution namely **School of Education VISTAS Vels University, Khasara No. 156/707, Plot No. 31, Off OMR (IT Highway), Thalambur Village & Post Office, Thiruporur Taluk, Chennai City, Kanchipuram District, Tamilnadu-600130** run by **Sri Balaji Charitable and Educational Trust, Khasara No. 156/707, Plot No. 31, Off OMR (IT Highway), Thalambur Village & Post Office, Thiruporur Taluk, Chennai City, Kanchipuram District, Tamilnadu-600130** vide SRC order No. F.SRO/NCTE/SRCAPP2312/B.Ed./TN/2016-17/85033 on 02.05.2016 for conducting B.Ed. course of one-year duration with an annual intake of 100 students (2 units) from the academic session 2016-2017.

2. **AND WHEREAS**, the SRC in its 408th meeting held on 02nd MARCH 2022 taken the decision to issue a Show Cause Notice to all the colleges of teacher education established even after NCTE Regulations, 2014 at the earliest in order to ascertain the compliance of NCTE Regulation, 2014. Accordingly, as per the decision of SRC, a Show Cause Notice was issued to the institution on 11.03.2022. The institution vide letter dated 28.03.2022 has submitted a reply to the Show Cause Notice.

3. **AND WHEREAS**, the SRC in its 411th meeting held on 23rd – 24th May 2022 has considered the matter and decided to issue a Final Show Cause Notice. Accordingly, as per the decision of SRC, a Final Show Cause Notice was issued to the institution on 04.06.2022. The institution vide letter dated 22.06.2022 has submitted a reply to the Final Show Cause Notice.

4. **AND WHEREAS**, the SRC in its 412th Meeting held on 05th – 06th July, 2022 considered the matter and decided as follows: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

*The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution **School of Education VISTAS Vels University, Survey No. 156 No. 31, Thalambur Village, Thiruporur Taluk & Post Office, Thiruporur Taluk, Chennai City, Kanchipuram District, Tamilnadu-600130** for B.Ed. programme for 2 basic units of 50 student each".*

5. **NOW THEREFORE**, this order is issued permitting the institution i.e **School of Education VISTAS Vels University, Survey No. 156 No. 31, Thalambur Village, Thiruporur Taluk & Post Office, Thiruporur Taluk, Chennai City, Kanchipuram District, Tamilnadu-600130** run by **Sri Balaji Charitable and Educational Trust, Khasara No. 156/707, Plot No. 31, Off OMR (IT Highway), Thalambur Village & Post Office, Thiruporur Taluk, Chennai City, Kanchipuram District, Tamilnadu-600130** for

Continuation of recognition for **B.Ed. programme** for two years duration with an annual intake of **2 basic units of 50 students each** subject to fulfilment of the following conditions:

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
 - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
 - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
 - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
6. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
7. The institution shall submit to the Regional Committee as Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
8. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely: -
- a. Sanctioned programme(s) along with annual intake in the institution:
 - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - c. Name of faculty members who left or joined during the last, quarter:
 - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
 - e. Fee charged from students.
 - f. Available infrastructural facilities.
 - g. Facilities added during the last quarter.
 - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
 - i. The affidavit with enclosure submitted along with application.
 - j. The institution shall be free to post additional relevant information if it so desires.

k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

9. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.

10. The institution shall make available the list of students admitted on its official website.

11. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made or issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provision of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
