WHEREAS, recognition u/s14 Act of NCTE, 1993 was granted to the institution namely, Rangumudri College of Education, Palakonda Revenue Division Iruvada Village Vangara Mandal Srikakulam District-535557, Andhra Pradesh vide order No. F.AP/NEW/B.ED/219/SRO/NCTE/2002-2003/6146 dated 03.03.2003 for conducting (B.Ed.) Course of one year duration with an annual intake of 100 students.

- 2. AND WHEREAS, after promulgation of NCTE Regulations, 2014, the institution had consented to come under new Regulations vide a notarized affidavit dated 31.12.2014. A revised provisional recognition order was issued on 26.05.2015 to the institution for conducting B.Ed. programme of two years duration with an annual intake of 100 students (two basic units) from the academic session 2015-16.
- 3. AND WHEREAS, the SRC in its 369th meeting held on 28.01.2019 and the Committee decided to Show Cause Notice be issued to all such institution which have not submitted compliance. Accordingly, as per the decision a Show Cause Notice issued on 13.05.2019. The institution has submitted reply received on 14.06.2019.
- 4. AND WHEREAS, the SRC in its 381st meeting held on 31st Oct & 01st Nov, 2019 considered the matter and decided to issue Show Cause Notice in all such matters where the institution has not submitted the requisite documents/VT report accompanied with the requisite documents in response to RPRO issued by the SRC. Accordingly, a First Show Cause Notice issued to the institution on 20.11.2019. The institution has submitted reply on 09.12.2019.
- 5. AND WHEREAS, the SRC in its 388th meeting held on 14th -15th September 2020 considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per decision of SRC a Final Show Cause Notice was issued to the institution on 21.09.2020. The institution has submitted reply on 08.10.2020.
- 6. AND WHEREAS, the SRC in its 395th meeting held on 25th -26th February 2021 considered the matter and decided to issue a last reminder letter. Accordingly, as per decision of SRC a last reminder letter was issued to the institution on 08.03.2021. The institution has submitted reply on 09.04.2021.
- 7. **AND WHEREAS**, the SRC in its 412st meeting held on 05th -06th July 2022 has considered the matter and the following observations were made:

(i) The institution failed to submit reply to the Last Reminder Letter 08.03.2021.

Hence the recognition granted to Rangumudri College of Education, Palakonda Revenue Division, Iruvada Village, Vangara Mandal, Srikakulam District-535557, Andhra Pradesh for B.Ed. course is withdrawn under Section 17(1) of NCTE Act, 1993 from the end of next academic session i.e. 2023-2024. On withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body from the next academic session stands withdrawn. Hence, the institution is not entitled to participate in counselling / making admissions from the next academic session i.e. 2023-2024.

- 8. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Rangumudri College of Education, Palakonda Revenue Division, Iruvada Village, Vangara Mandal, Srikakulam District-535557, Andhra Pradesh for conducting B.Ed. Programme of two years duration with an annual intake of 100 students (Two basic units) with effect from the end of next academic session i.e., 2023-2024 onwards. Further, on withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body from the academic session stands withdrawn. Hence, the institution is not entitled to participate for counseling from the academic session i.e., 2023-2024 and the institution is also not permitted to take any fresh admission of students from the academic session 2023-2024.
- **9.** Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

10. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
