WHEREAS, recognition u/s 14 Act of NCTE, 1993 was granted to the institution namely, The Chikkodi Taluka Education Society's College of Education, C/o. R.D. Complex, P.U. College Campus, Chikkodi-591201, Belgaum District, Karnataka vide order no. F.SRO/NCTE/B.Ed/2004-2005/8766 dt. 29.11.2004 for conducting Secondary B.Ed. programme of one years duration with annual intake of 100 students from the academic sessions 2004-2005.

- AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution had submitted affidavit dated 27.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 31.05.2015 for conducting B.Ed. Programme of two years duration with an annual intake of 50 students (one basic unit) from the academic session 2015-16.
- AND WHEREAS, the SRC in its 375th Meeting held on 13th & 14th May, 2019 the matter was considered and decided to issue common SCN to all such institutions (one unit or two or more unit cases) and the status of issuance of SCN/FSCN was considered by the Sub-Committee constituted requisite documents or only part reply has been submitted. The Sub-Committee decided to issue SCN in all such cases. Accordingly, as per decision of SRC First Show Cause Notice was issued to the institution on 30.09.2019. The institution has not submitted reply to the Show Cause Notice.
- AND WHEREAS, the SRC in its 413th meeting held on 22nd 23rd August, 2022 has considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per the decision of SRC a Final Show Cause Notice was issued to the institution on 05.09.2022. The institution has submitted reply on 10.09.2022.
- AND WHEREAS, the SRC in its 414th meeting held on 26th 27th September 2022 5. has considered the matter and decided as follows:-

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made were made: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution The Chikkodi Taluka Education Society's College of Education, C/o. R.D. Complex, P.U. College Campus, Survey No. 165/B, R.D.P.U. College, Campus, N-M. Road, Chikkodi, Belgaum District, Karnataka-591201 for B.Ed. programme for 1 basic unit of 50 students.

**District, Karnataka-591201** for Continuation of recognition for **B.Ed. programme** for two years duration with an annual intake of **1 basic unit of 50 students** subject to fulfilment of the following conditions: -

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 7. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- **8.** The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 9. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
  - a. Sanctioned programme(s) along with annual intake in the institution:

  - j. The institution shall be free to post additional relevant information if it so desires.

- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 10. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 11. The institution shall make available the list of students admitted on its official website.
- 12. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
