WITHDRAWAL ORDER

WHEREAS, recognition u/s14(3)(a) of NCTE Act, 1993 was granted to the institution namely, Amman Teacher Training Institute, No.92/1A, Scheme Road, YMR Patty, Dindigul-624001, TamilNadu vide SRC (NCTE) order no. SRO/NCTE/D.T.Ed./2005-2006/5109 dated 04.01.2006 for conducting D.T.Ed. Course of two years duration with an annual intake of 50 students from the academic session 2005-2006.

- 2. AND WHEREAS, additional recognition u/s14(3)(a) of NCTE Act, 1993 was granted to the institution namely, Amman Teacher Training Institute, No.92/1A, Scheme Road, YMR Patty, Dindigul-624001, TamilNadu vide SRC (NCTE) vide order no. SRO/NCTE/D.T.Ed.-A.I./2006-2007/10089 dated 09.01.2007 for conducting Elementary D.T.Ed. Course (Additional Intake) of two years duration with an annual intake of 100 students (which includes the existing intake of 50(Fifty) + 50 additional.)
- 3. AND WHEREAS, a letter was received from the institution on 14.06.2017 and 01.09.2022 requesting for closure.
- **4. AND WHEREAS,** initial recognition of 50 intake granted vide order dated 04.01.2006 has been withdrawn vide Order No.F.SRC/NCTE/APS03628/D.T.Ed./TN/2022/136328-136332 dated 14.10.2022 as per the decision taken in SRC 414th meeting held on 26th and 27th September 2022.
- **5. AND WHEREAS,** the SRC in its 415th Meeting of SRC held on $03^{rd} 04^{th}$ November 2022 considered the matter for closure of the D.T.Ed. Programme(Additional Intake) and decided as under: -

"The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee noted that the institution has not filled Performance Appraisal Report (PAR)

The Committee agreed to close down the institution as requested by the Institution on 01.09.2022 by withdrawing the recognition granted to Amman Teacher Training Institute, No.92/1A, Scheme Road, YMR Patty, Dindigul-624001, TamilNadu for conducting D.T.Ed-Al Programme under clause 17(1) of NCTE Act, 1993 from the academic session 2022-2023.

- 6. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby agreed to close down the institution as requested by withdrawing recognition granted to Amman Teacher Training Institute, No.92/1A, Scheme Road, YMR Patty, Dindigul-624001, TamilNadu for conducting D.T.Ed. additional Programme of two years duration with an annual intake of 50 students (one unit) with effect from the academic session i.e., 2022-2023 onwards.
- 7. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

8. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
