WHEREAS, the recognition u/s 14(3)(a) of NCTE Act.1993 was granted to the institution namely Cosmopolitan College of Education, Sengadu Village Sriperambudur Street, Chennai Taluk, Kancheepuram District-602002, Tamilnadu run by Cosmopolitan Educational Cultural & social Development Trust, Sengadu Post, Sriperambathur, Kancheepuram, Tamilnadu vide Order F.SRO/NCTE/SRCAPP201630153/M.Ed/TN/2017-2018/97880-97887 dated 23.08.2018 for conducting M.Ed. programme of two-years duration with an annual intake of 50 students from the academic session 2019-2020.

- 2. AND WHEREAS, the SRC in its 388th meeting held on 14th and 15th September 2020 considered the matter and decided to issue a Show Cause Notice to all the institutions wherein Recognition was accorded by the SRC under Regulations 2014 with the direction to submit all requisite documents. Accordingly, as per decision of SRC, a Show Cause Notice was issued to the institution on 02.08.2021. The management of the institution vide letter dated 18.08.2021 submitted reply to the Show Cause Notice.
- 3. AND WHEREAS, the SRC in its 402nd Meeting held on 13th and 14th September, 2021 the matter was considered and decided to issue Final Show Cause Notice to the institution. Accordingly, as per the decision of SRC a Final Show Cause Notice was issued to the institution on 08.10.2021 to B.Ed. & M.Ed. Programme. The management of the institution has not submitted reply of Final Show Cause Notice in M.Ed. programme.
- **4. AND WHEREAS,** the SRC in its 415th Meeting held on 03rd and 04th November 2022 considered the matter regarding request for closure and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

(i) The institution failed to submit reply to the Final Show Cause Notice dated 08.10.2022.

Hence the recognition granted Cosmopolitan College of Education, Cosmopolitan Educational Cultural & Social Development Trust, Sengadu P.O., Sriperambathur, Chennai, Kancheepuram – 602002, Tamilnadu for M.Ed. course is withdrawn under Section 17(1) of NCTE Act, 1993 from the end of next academic session i.e. 2023-2024. On withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE

- 5. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of Cosmopolitan College of Education, Sengadu Village Sriperambudur Street, Chennai Taluk, Kancheepuram District-602002, Tamilnadu run by Cosmopolitan Educational Cultural & social Development Trust, Sengadu Post, Sriperambathur, Kancheepuram, Tamilnadu for conducting M.Ed. programme of two-year duration with an annual intake of 50 students from the end of next academic session i.e. 2023-2024. On withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body from the next academic session stands withdrawn.
- **6.** Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

"यदि कोई संस्था उप-धारा (1) के तहत मान्यता वापस लेने के आदेश के लागू होने के बाद शिक्षक शिक्षा में कोई पाठ्यक्रम या प्रशिक्षण प्रदान करती है या जहां कोई संस्थान नियत दिन से ठीक पहले शिक्षक शिक्षा में पाठ्यक्रम या प्रशिक्षण प्रदान करने में विफल रहता है या इस अधिनियम के तहत मान्यता या अनुमति प्राप्त करने हेतु उपेक्षा करता है, तो ऐसे पाठ्यक्रम या प्रशिक्षण के अनुसार या ऐसी संस्था में पाठ्यक्रम या प्रशिक्षण लेने के बाद प्राप्त शिक्षक शिक्षा में योग्यता को केंद्र सरकार, किसी राज्य सरकार या विश्वविद्यालय या केन्द्रीय सरकार या किसी राज्य सरकार व्वारा सहायता प्राप्त किसी स्कूल, कॉलेज या अन्य शैक्षिक संस्था में रोजगार के उद्देश्य के लिए वैध योग्यता के रूप में नहीं माना जाएगा।")

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order.
