WHEREAS, the recognition was granted to the institution namely, Sri Taralabalu Jagadguru College of Physical Education, Anubhavamantapa, Davanagere, Karnataka-577004 run by Sri Taralabalu Jagadguru Education Society, Karnataka vide SRC vide order no. F.SRO/NCTE/B.P.Ed./2005-2006/3325 dt. 05.10.2005 for B.P.Ed. course of one year duration from the academic session 2005-2006 with an annual intake of 50 students.

- AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dated 16.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 20.05.2015 for conducting B.P.Ed. programme of two years duration with an annual intake of one basic unit of 100 (two sections of 50 students each) from the academic session 2015-16.
- AND WHEREAS, the SRC in 369th Meeting held on 28.01.2019 considered the matter 3. and decided to issue SCN in all such matters where the institution has not submitted the following requisite documents/VT Repost accompanied with requisite documents in respond to RPRO issued by the SRC. Accordingly, as per decision of SRC a Show Cause was issued to the institution on 16.05.2019. The institution did not submit reply to the Show Cause Notice.
- AND WHEREAS, the SRC in its 388th meeting held on 14th 15th September, 2020 considered the matter and decided to issue SCN/FSCN in all RPRO cases asking them to submit all the required documents as per the 13 points. Accordingly, as per decision of SRC Final Show Cause Notice was issued to the institution on 13.10.2020. The institution vide letter dated 20.11.2020 has requested for closure of the B.P.Ed. Programme.
- AND WHEREAS, the SRC in its 405th Meeting held on 13th & 14th December, 2021 considered the request for closure of the B.P.Ed. Programme matter and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee agreed to close down the institution as requested by the institution vide dated 20.11.2020 by withdrawing the recognition granted to Sri Taralabalu Jagadguru College of Physical Education, Anubhavamantapa, Davanagere, Karnataka-577004 for conducting B.P.Ed. Programme under clause 17(1) of NCTE Act. 1993 from the academic session 2021-2022.

However, the FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director as per the general resolution taken by the SRC in this meeting."

- 6. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Sri Taralabalu Jagadguru College of Physical Education, Anubhavamantapa, Davanagere, Karnataka-577004 run by Sri Taralabalu Jagadguru Education Society, Karnataka for conducting B.P.Ed. programme of two years duration with an annual intake of one basic unit of 100 (two sections of 50 students each) with effect from the academic session i.e., 2021-2022 onwards.
- 7. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

8. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
