#### **ORDER**

WHEREAS, the institution namely **Sri Rajarajeswari College of Education, 214/3, Trichy – Chennai NH-45, Siruganur, (Opp. to Govt. Hr. School) Trichy, Tamilnadu-621105** was granted recognition for conducting (B.Ed.) course of one-year duration with an annual intake of 100 students vide SRC, NCTE's vide order no. F.SRO/NCTE/2007-2008/18576 dated 06.03.2008.

AND WHEREAS, the Tamilnadu Teachers Education University had forwarded a copy of show cause notice issued to the institution for not functioning in accordance with the conditions stipulated by the NCTE, SRC, Bangalore and Tamilnadu Teachers Education University as could be apprehended from the report of Inspection commission which caused a surprise visit to the colleges.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dt. 09.02.2015 for its willingness of two units in B.Ed. course and adherence of provisions of new Regulations.

AND WHEREAS, provisional revised recognition order was issued to the institution on 31.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 for two basic units of 50 students from the academic session 2015-2016 with a condition to maintain.

AND WHEREAS, the SRC in its 290<sup>th</sup> meeting considered and decided the written reply of the institution received on 30.05.2015 and decided to withdraw the recognition. Accordingly, a withdrawal order was issued on dt. 05.10.2015. The institution preferred an appeal on 13.01.2016 and the Appellate Authority remanded back the case of the institution.

AND WHEREAS, the SRC in its 309<sup>th</sup> Meeting held on 12<sup>th</sup> to 14<sup>th</sup> April 2016 considered the appellate authority order and institution written representation and it has decided to restore recognition and ask the institution to submit staff list for the second unit. Accordingly, as per decision restore recognition order was issued to the institution on dt. 02.05.2016.

AND WHEREAS, the SRC in its 314<sup>th</sup> Meeting held on 27<sup>th</sup> & 28<sup>th</sup> May 2016 considered the institution written representation for shifting order and it has decided to "the request if accepted issue permission for the shifting already done." Accordingly, permission is hereby accorded to Sri Rajarajeswari College of Education, No. 36 A & B, Town Station Road, Triruchirappalli District, Pin -62002, TamilNadu to shift its premises to new location/building at Sri Rajarajeswari College of Education, 214/3, Trichy – Chennai NH-45, Siruganur, (Opp. to Govt. Hr. School) Trichy, Tamilnadu-621105 vide order no. F.SRO/NCTE/APSO4929/B.Ed./TN/2016-2017/85789 on dt. 01.06.2016.

AND WHEREAS, the SRC in its 369<sup>th</sup> Meeting held on 28.01.2019 and Committee decided that Show Cause Notice to be issued to all such institution which have not submitted compliance. Accordingly, as per the decision of SRC a Show Cause Notice was issued to the institution on 25.03.2019. The institution has not submitted any reply in respect of Show Cause Notice.

AND WHEREAS, the matter was further considered by the Sub-Committee constituted by the SRC as per its decision taken in 380<sup>th</sup> Meeting. The Sub-Committee of the SRC decided to issue Final Show Cause Notice to all such institution where reply to SCN has not been submitted by the institution. Accordingly, as per decision a Final Show Cause Notice was issued to the institution on dt. 28.10.2019.

AND WHEREAS, the SRC in its 380<sup>th</sup> Meeting, a common decision was passed against the institution which have notice returned as undelivered with a remark from the Postal Authority as "Left". The institution has not submitted any reply till date.

AND WHEREAS, SRC in its 384<sup>th</sup> Meeting held on 12<sup>th</sup> & 13<sup>th</sup> February 2020 the matter was placed before the Committee considered and decided to issue a Withdrawal order to the institution. Accordingly, as per decision a Withdrawal order was issued to the institution on dt. 19.02.2020.

AND WHEREAS, the institution preferred an appeal u/s 17 of NCTE Act, 1993 and the Appellate Authority vide order No. F.No.89-181/E-164260/2020 Appeal/26<sup>th</sup> Mtg.-2020/27<sup>th</sup> October, 2020/95242 dt.27.11.2020 remanded back the matter to SRC. Therefore, as per the hearing committee instructions, the institution has submitted documents on dt. 02.12.2020.

AND WHEREAS, the matter was placed before the SRC in its  $392^{nd}$  meeting held on  $15^{th}-16^{th}$  December, 2020 considered and decided to issue a letter to the institution. Accordingly, a letter was issued to the institute vide dated 28.12.2020. The institution has submitted its reply along with the latest staff list in prescribed format vide dated 06.10.2021.

AND WHEREAS, the matter was placed before the SRC in its  $393^{rd}$  meeting held on  $5^{th}$  –  $6^{th}$  January, 2021 considered and decided as the following grounds:

"The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

On the perusal of the reply submitted by the institution, the Committee decided that the continuation order be issued to the Institution Sri Rajarajeswari College of Education, 214/3, Trichy Chennai NH 45, Siruganur, (Opp to Govt Hr School) Trichy, Tamil Nadu 621105 for B.Ed programme for 2 basic units (50 students each unit)."

NOW THEREFORE, this order is issued permitting the institution i.e. **Sri Rajarajeswari College of Education**, **214/3**, **Trichy – Chennai NH-45**, **Siruganur**, **(Opp. to Govt. Hr. School) Trichy**, **Tamilnadu-621105** for continuation of recognition for B.Ed. programme for 2 basic units of 50 students each unit subject to fulfilment of the following conditions:

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 1. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc as applicable.
- 2. The institution shall submit to the Regional Committee a Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 3. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:-

- a. Sanctioned programme(s) along with annual intake in the institution:
- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c. Name of faculty members who left of joined during the last, quarter:
- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- e. Fee charged from students;
- f. Available infrastructural facilities;
- g. Facilities added during the last quarter;
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information, if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 4. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 5. The institution shall make available the list of students admitted on its official website.
- 6. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
