WITHDRAWAL ORDER

WHEREAS, recognition was granted to the institution namely P.K.D. College of Education, 30/12, Venkataraman Road, Mahallingapuram, Pollachi-642002, Tamilnadu vide SRC (NCTE) order no. F.SRO/NCTE/D.T.Ed./2006-2007/9697 dated 23.12.2006 for conducting D.T.Ed. course of two years duration with an annual intake of 50 (fifty) Elementary (D.T.Ed.) students from the academic session 2006-2007.

AND WHEREAS, the institution vide letter dated 11.12.2000 has requested to close the recognition granted to the institution for running B.Ed. & D.T.Ed course from the 2020-21 academic session. The institution has submitted NOC from the affiliating University & Staff.

AND WHEREAS, the matter was placed before the SRC in its 393rd meeting held on 5th - 6th January, 2021 considered and decided as the following grounds:

"The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:

The Committee decided to withdraw the recognition granted to P.K.D. College of Education, 30/12, Venkataraman Road, Mahalingapuram, Pollachi 642002, Tamil Nadu for conducting B.Ed & D.T.Ed courses under clause 17(1) of NCTE Act, 1993 on its own request by the institution vide its letter dt 11.12.2020. However, the FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director on the submission of the following:

- (a) NOC from the affiliating body.
- (b) NOC from the staff/faculty.
- (c) Resolution of the management to the effect for closure of the course."

NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of P.K.D. College of Education, 30/12, Venkataraman Road, Mahallingapuram, Pollachi-642002, Tamilnadu vide SRC (NCTE) order no. F.SRO/NCTE/D.T.Ed./2006-2007/9697 dated 23:12.2006 for conducting D.T.Ed. course of two years duration with an annual intake of 50 (fifty) Elementary (D.T.Ed.) from the next academic session starts after issuance of this order.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order Withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purposes of employment under the Central Government, any State Government or University, or in any School, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an appeal u/s 18 of the NCTE Act, 1993, through "Online mode" available on NCTE's website www.ncte-india.org, within 60 days from the date of issue of this order. The guidelines for filling appeal may be seen on NCTE's website.
