WHEREAS, the institution Kongunaadu College of Education for Women, Mamangam Post, Salem – 636302, Tamilnadu run by Kongunaadu Educational Trust, Salem District, Tamilnadu – 636302 was granted recognition vide SRC (NCTE) order no. F.SRO/NCTE/2007-2008/15786 dt. 07.12.07 for conducting B.Ed. course of one-year duration with an annual intake of 100 students from the academic session 2007-2008.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dt. 27.02.2015 for its willingness of two units in B.Ed. course and adherence of provisions of new Regulations.

AND WHEREAS, the Southern Regional Committee (NCTE) issued the revised provisional recognition order dt. 05.05.2015 to Kongunaadu College of Education for Women, Mamangam Post, Salem – 636302, Tamilnadu for conducting B.Ed. course of two years duration with an annual intake of 100 students (two basic units of 50 students each) from the academic session 2015-2016 subject to fulfilment of conditions mentioned therein.

AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the SRC in its 369th meeting held on 28.01.2019 and the committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance.

AND WHEREAS, a Show Cause Notice was issued to the institution on 26.03,2019. The institution has submitted a letter on 09.04,2019 in reply of Show Cause Notice stating as under:

We have received a show cause notice regarding NCTE regulation 2014 on 26.03.2019. We have already sent a communication to the NCTE office dt 11.05.2015 requesting to reduce from two basic units to one basic unit (50 students). Regarding the above till date we are not in receipt any communication from your office.

From the above information you may find that our college has admitted only one basic unit (50 students) and the same may be followed for the forthcoming years also.

So, we request you to kindly allow us to admit one basic unit only (50 Students) for our college from the academic year 2015-2016 onwards. This is for your kind perusal." Here, it is submitted that: -

- 1. The institution has not submitted a copy of staff profile of qualified staff appointed by the institution, duly approved by the affiliating university for the session 2015-16, 2016-17, 2017-18, 2018-19, 2019-20 sufficient for even one unit (50 students) of B.Ed. course
- 2. The institution is not maintaining FDR of Rs 12 Lakh in the joint operation with RD, SRC.

AND WHEREAS, the above matter was placed before the SRC in its 379th meeting. The Committee considered the matter and decided to issue Final Show Cause Notice. Accordingly, a Final Show Cause Notice was issued on 06.09.2019. The institution has submitted its reply on 24.09 2019

AND WHEREAS, The matter was placed before the SRC in its 386th meeting held on 23rd – 24th July 2020 considered the matter and decided to issue a Withdrawal Order, a withdrawal order was issued to the institution vide dt.04.09.2020.

AND WHEREAS, the institution preferred an appeal u/s 17 of NCTE Act, 1993 and the Appellate Authority vide order No. F.No.89-222/E-167244/2020 Appeal/29th Mtg.-2020/02nd December 2020/95605 dt.16.12.2020 remanded back the matter to SRC. The operative part of the order is as under:

"AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and arguments advanced during online presentation of appeal, Appeal Committee concluded to remand back the case to SRC for revisiting the matter. Appellant institution is required to submit to SRC within 15 days of the issue of appeal order copies of approved (i) Building Plan, (ii) Building Completion Certificate, (iii) Faculty and English version of Non-Encumbrance Certificate and the revalidated FDRs."

AND WHEREAS, the institute has submitted its reply along with documents vide dated 29.12.2020 and the matter was considered by the SRC in its 393rd meeting held on 05th -06 January 2021 as under: -

"The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

On the perusal of the reply submitted by the institution the Committee decided that the continuation order be issued to the Institution Kongunaadu College of Education for Women, Mamangam Post, Salem – 636302, Tamilnadu for the following courses: -

B.Ed. - 1 units (50 students)

Now therefore, the SRC decided to permit the institution i.e. Kongunaadu College of Education for Women, Mamangam Post, Salem – 636302, Tamilnadu for

B.Ed. course run by Kongunaadu Educational Trust, Salem District, Tamilnadu 636302 for continuation of recognition for B.Ed. course of two years duration with an annual intake of 50 students (one basic unit) subject to fulfilment of the following conditions:

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position
- V. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 12. Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc. as applicable.
- 13. The institution shall submit to the Regional Committee a Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 14. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned.

The information with regard to the following shall also be made available on the website namely: -

- a. Sanctioned programme(s) along with annual intake in the institution.
- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c. Name of faculty members who left of joined during the last, quarter:
- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
- e. Fee charged from students.
- f. Available infrastructural facilities.
- g. Facilities added during the last quarter.
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information, if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 15. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 16. The institution shall make available the list of students admitted on its official website.
- 17. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the

Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
