### WITHDRAWAL ORDER

College of Education, namely J. K. WHEREAS the institution Kannakurumbi, Arantangi, Pudukkottai Narpavalakkudi, Tamilnadu-614616 was granted recognition vide SRC (NCTE) order no. F.SRO/NCTE/B.Ed./2007-2008/2054 dt. 05.06.2008 for conducting B.Ed. course of one-year duration with an annual intake of 100 students from the academic session 2007-2008.

AND WHEREAS, on promulgation of NCTE Regulation, 2014, the institution has submitted affidavit dt. 29.01.2015 for its willingness of two units in B.Ed. course and adherence of provisions of new Regulation.

AND WHEREAS, provisional revised recognition order was issued to the institution on 30.04.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-2016.

AND WHEREAS, the matter was placed before in 314th meeting of SRC held on 27th & 28th May 2016 wherein a general decision was taken to cause inspection of such cases.

AND WHEREAS, as per the decision of SRC, a letter for inspection was sent on 14.06.2016 and the inspection was conducted on 16.10.2016 to 06.11.2016.

AND WHEREAS, the matter was placed before the SRC in its 380<sup>th</sup> Meeting held on 18th & 19th September 2019 wherein the Committee considered the matter and decided a Final Show cause notice was issued to the institution. As per the decision a Final Show Cause Notice was issued to the institution on 04.10.2019. The institution submitted its reply along with documents dt. 23.10.2019.

**AND WHEREAS**, the SRC in its 386<sup>th</sup> Meeting held on 23<sup>rd</sup> & 24<sup>th</sup> July 2020 the matter was placed before the Committee and considered the Show Cause Notice's reply submitted by the institution on dt. 23.10.2019 and found the following deficiencies: -

- 1. The Lease Deed dt. 23.10.2019 executed between private parties are not acceptable/allowed under NCTE Regulations, 2014.
- 2. Other documents like Building Plan, NEC, CLU and BCC are not acceptable under NCTE Regulations.
- 3. The size of Multipurpose Hall is less than the requirement of NCTE Regulations, 2014.
- 4. The FDR of Rs. 4 Lakhs submitted by the institute is from Lakshmi Vilas Bank, which is not acceptable as per NCTE Regulations,
- 5. The institute failing in submission of faculty list duly approved by the Competent authority.

**AND WHEREAS**, as per directed a Final Show Cause Notice was issued to the institution on dt. 04.08.2020.

**AND WHEREAS**, the SRC in its 393<sup>rd</sup> Meeting held on 05<sup>th</sup> & 06<sup>th</sup> January 2021 and considered the matter as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

1. The institution has not responded to the Final Show Cause Notice issued on 04.08.2020.

NOW THEREFORE, the Committee decided to withdraw the recognition granted to J. K College of Education, Narpavalakkudi, Kannakurumbi, Arantangi, Pudukkottai District, TamilNadu for conducting B.Ed course w.e.f. the next academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order Withdrawing Recognition under subsection (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purposes of employment under the Central Government, any State Government or University, or in any School, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal u/s 18 of the NCTE Act, 1993, through "online mode" available on NCTE's website <a href="www.ncte-india.org">www.ncte-india.org</a>, with 60 days from the date of issue of this order. The guidelines for filling appeal may be seen on NCTE's website.
