WITHDRAWAL ORDER

WHEREAS, recognition u/s14 (3)(a) of NCTE Act, 1993 was granted to the institution namely, Puratchi Thalaivar Dr. MGR College of Education, Kalkinatruvalasai, Keela Nagatchi Post, Uchippuli-623534, Ramanathapuram District, TamilNadu run by Puratchi Thalaivar Dr. MGR Educational & Welfare Trust, Collectorate Post, Bharathi Nagar, TamilNadu for B.Ed. Course Vide SRC (NCTE) Order No. F.SRO/NCTE/B.Ed./2006-2007/8111 dated 03.10.2006 for conducting Secondary B.Ed. Course of one year duration with an annual intake of 100 students form the academic session 2006-2007.

- 2. AND WHEREAS, after promulgation of NCTE Regulations, 2014, the institution by consented to come under new Regulations vide a notarized affidavit dated 20.01.2015 and the Revised Provisional Recognition Order (RPRO) was issued to the institution on 01.05.2015 for conducting B.Ed. Programme of two years duration with an annual intake of 100 students for two basic units of 50 students each from the academic session 2015-16.
- **3. AND WHEREAS,** the SRC in its 421st meeting held on 10th February 2023 has considered the matter and decided to issue a Final Show Cause Notice. Accordingly, as per the decision of SRC, a Final Show Cause Notice was issued to the institution on 21.02.2023. The institution has submitted a reply to the Final Show Cause Notice on 09.03.2023.
- **4. AND WHEREAS**, the SRC in its 427th Meeting held on 20th July 2023 considered the matter and found some deficiencies in reply to Final Show Cause Notice and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made:

The institution was issued a Final Show Cause Notice (FSCN). The institution has submitted its reply vide letter dated 09.03.2023. The Committee perused the reply submitted by the institution and found the following deficiencies.

(i) The institution has submitted 9 members faculty list which is not sufficient to run 2 units of B.Ed. programmes as per NCTE Regulations for two basic units.

Hence the recognition granted Puratchi Thalaivar Dr. MGR College of Education, Kalkinatruvalasai, Keela Nagatchi Post, Uchippuli-623534, Ramanathapuram District, TamilNadu for B.Ed. programme is withdrawn under Section 17(1) of NCTE Act, 1993. No fresh admissions are permitted now onwards. However, if any student is pursuing B.Ed. programme is allowed to continue till they complete the course. On withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body shall also be withdrawn".

- 5. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Puratchi Thalaivar Dr. MGR College of Education, Kalkinatruvalasai, Keela Nagatchi Post, Uchippuli-623534, Ramanathapuram District, TamilNadu for conducting B.Ed. Programme of two years duration of 100 students for two basic units. No fresh admissions are permitted now onwards. However, if any student is pursuing B.Ed. programme is allowed to continue till they complete the course. On withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body shall also be withdrawn.
- 6. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act, 1993: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

(6. इसके अलावा, संस्था और संबद्ध निकाय को एनसीटीई अधिनियम, 1993 की धारा 17(4) के निम्नलिखित प्रावधानों के बारे में सूचित किया जाता है: -

"यदि कोई संस्था उप-धारा (1) के तहत मान्यता वापस लेने के आदेश के लागू होने के बाद शिक्षक शिक्षा में कोई पाठ्यक्रम या प्रशिक्षण प्रदान करती है या जहां कोई संस्थान नियत दिन से ठीक पहले शिक्षक शिक्षा में पाठ्यक्रम या प्रशिक्षण प्रदान करने में विफल रहता है या इस अधिनियम के तहत मान्यता या अनुमित प्राप्त करने हेतु उपेक्षा करता है, तो ऐसे पाठ्यक्रम या प्रशिक्षण के अनुसार या ऐसी संस्था में पाठ्यक्रम या प्रशिक्षण लेने के बाद प्राप्त शिक्षक शिक्षा में योग्यता को केंद्र सरकार, किसी राज्य सरकार या विश्वविद्यालय या केन्द्रीय सरकार या किसी राज्य सरकार द्वारा सहायता प्राप्त किसी स्कूल, कॉलेज या अन्य शैक्षिक संस्था में रोजगार के उद्देश्य के लिए वैध योग्यता के रूप में नहीं माना जाएगा।")

7. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte.gov.in within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
