ORDER

WHEREAS, the recognition was granted to the institution namely **Rashtriya Sanskrit Vidhyapeeta, Tirupathi - 51704, Chittoor District, Andhra Pradesh** vide SRC (NCTE) order no. F.SRO/NCTE/B.Ed-AI/2008-09/6031 dt. 15.10.2008 for conducting B.Ed. course of one-year duration with an annual intake of 127 students.

2. **AND WHEREAS**, on 02.03.2015, the institution has submitted an affidavit affirming adherence to Regulations, 2014 and sought for an intake of 100 students for the B.Ed programme and an intake of 50 students for M.Ed programme as per Regulations, 2014.

3. **AND WHEREAS**, a revised recognition order for offering the B.Ed course with an intake of 100 students (2 units) was issued vide order No. F.No. SRO/NCTE/APSO9601/B.Ed/AP/2015/65123 dated 19.5.2015.

4. **AND WHEREAS**, the SRC in its 381st meeting held on 31st Oct 01st Nov 2019 considered the matter and decided to issued SCN in all such matters where the institution has not submitted the following requisite documents/VT report not accompanied with the requisite documents in response to RPRO issued by the SRC. Accordingly, Final Show Cause Notice was issued on 13.11.2019. The institutions vide letter dated 02.12.2019 submitted reply to the Final Show Cause Notice. The SRC in its 384th meeting held on 12th – 13th February, 2020 considered the matter and decided as under:-

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

On the perusal of the reply, documents and records submitted by the Institution, Committee decided that the **continuation order** be issued to the Institution **Rashtriya Sanskrit Vidyapeetha, Tirupati-517064, Chittoor district, Andhra Pradesh** for B.Ed programme for 2 basic units (50 students each unit).

5. **NOW THEREFORE**, this order is issued permitting the institution i.e. **Rashtriya Sanskrit Vidyapeetha, Sy.No. 588/A, Tirupati-517064, Chittoor district, Andhra Pradesh** run by **Rashtriya Sanskrit Sansthan, Sy.No. 588/A, Tirupati-517064, Chittoor district, Andhra**

Pradesh for continuation of recognition for B.Ed course of two years duration with an intake of 100 students (Two units) of subject to fulfillment of the following conditions:

- I. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
 - II. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
 - III. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
6. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc as applicable.
7. The institution shall submit to the Regional Committee as Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
8. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:-
- a. Sanctioned programme(s) along with annual intake in the institution;
 - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - c. Name of faculty members who left of joined during the last, quarter;
 - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
 - e. Fee charged from students;
 - f. Available infrastructural facilities;
 - g. Facilities added during the last quarter;
 - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
 - i. The affidavit with enclosure submitted along with application.
 - j. The institution shall be free to post additional relevant information, if it so desires.
 - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
9. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.

10. The institution shall make available the list of students admitted on its official website.

11. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made or issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provision of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
