WHEREAS, recognition u/s 14 Act of NCTE, 1993 was granted to the institution namely, Shree Fulsing Narayan Chavan College of Education, S.J.V.V. Sanghs, Hittinhalli Tanda, Sindagi Taluk, Bijapur, Karnataka-586215 run by Shri Jagadamba Vidya Vardhak Sangh, Tamba, Bijapur, Karnataka vide order no. F.SRC/NCTE/2009/M.Ed./RO/12730 dt. 12730 for M.Ed. course of one year duration with an annual intake of 25 from the academic session 2009-2010.

- 2. AND WHEREAS, the Enhancement of intake of 10 seats from existing 25 to 35 is permitted to the institution. Accordingly, an order was issued to the institution on 24.08.2010.
- 3. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit on 21.01.2015 for its willingness of two units in B.Ed. course and adherence of provisions of new Regulations. Thereafter, a Revised Provisional Recognition Order was issued to the institution on 26.05.2015 for conducting M.Ed. programme of two years duration with an annual intake of 50 students (one unit) from the academic session 2015-2016.
- 4. AND WHEREAS, the SRC in 369th Meeting held on 28.01.2019 considered the matter and decided to issue SCN in all such matters where the institution has not submitted the requisite documents/VT Repost accompanied with requisite documents in respond to RPRO issued by the SRC. Accordingly, as per decision a Show Cause was issued to the institution on 25.04.2019. The institution did not submit any reply to Show Cause Notice.
- 5. AND WHEREAS, the matter was further considered by the Sub-Committee of the SRC as per decision taken in its 380th meeting. The Sub-Committee of the SRC decided to issue Final Show Cause Notice to all such institution where reply to SCN has not been submitted by the institution. Accordingly, a Final Show Cause Notice was issued to the institution on 15.10.2019. The institution vide letter dated 31.10.2019 has submitted in response to the Final Show Cause Notice
- 6. **AND WHEREAS**, the SRC in its 414th Meeting held on 26th & 27th September, 2022 considered the matter and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made were made: -

The institution was issued a Final Show Cause Notice (FSCN). The institution has submitted its reply vide letter dated 31.10.2019. The Committee perused the reply submitted by the institution and found the following deficiencies.

- 1. The institution has not submitted latest list of faculties in the prescribed format for M.Ed. programme duly approved by the Registrar of the affiliating body as per NCTE Regulations 2014.
- 2. As per building plan submitted by the institution multipurpose hall is not mentioned.
- 3. The BCC submitted by the institution shows the total built up area 2116.15 sq. ft only which is not sufficient as per NCTE Regulation 2014.
- 4. The institution did not submit original form 'A' issued by the bank regarding maintenance of FDRs towards Endowment and Reserve Fund.
- 5. The website of the institution is not uploaded with the information required under clauses 7(14)(i), 8(14) and 10(3) of NCTE Regulations, 2014.

Hence, the recognition granted to Shree Fulsing Narayan Chavan College of Education, S.J.V.V. Danghs, Hittinhalli Tanda, Sindagi Taluk, Bijapur-586215, Karnataka for M.Ed. course is withdrawn under Section 17(1) of NCTE Act, 1993 from the academic year 2023-2024. On withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body from the next academic session stands withdrawn."

- 7. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraw the recognition granted to Shree Fulsing Narayan Chavan College of Education, S.J.V.V. Danghs, Hittinhalli Tanda, Sindagi Taluk, Bijapur-586215, Karnataka run by Shri Jagadamba Vidya Vardhak Sangh, S.J.V.V. Danghs, Hittinhalli Tanda, Sindagi Taluk, Bijapur-586215, Karnataka for conducting M.Ed. programme of two years duration with an annual intake of 50 students (1 basic unit) with effect from the next academic session i.e., 2023-2024 onwards.
- 8. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any



State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

9. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
