ORDER

WHEREAS, the recognition was granted to the institution namely Government Teacher Training Institute, Chittur, Palakkad District, Kerala -678101 vide SRC (NCTE) order no. F/SRO/NCTE/98-99 / 2287 dt 16.10.1998 for conducting Elementary course of two-years duration with an annual intake of 40+40 (1 year + 2 year) students for one year 1998-99.

- AND WHEREAS, a notice dt 16.06.1999 was issued to the institution for 2. submission of written representation to the conditions mentioned therein.
- AND WHEREAS, the SRC in its 30th meeting held on 27th July 2000 considered the matter and decided to refuse the Recognition granted to the institution for Accordingly, an order Elementary programme. 74/SRO/NCTE/2000-2001 / 1771 dt 25.08.2000 was issued to the institution.
- AND WHEREAS, the institution preferred an Appeal and the Appellate Authority vide its order no. F.No 42-92/2001 Appeal / 16279 dt 07.01.2002 considered the Council hereby reverse the order appealed against and grants recognition to Govt. Teacher Training Institution, Palakkad for conducting Elementary Training course with an intake of 25 students in Malayalam Medium and 25 Students in Tamil Medium.
- AND WHEREAS, the above matter was deliberated again in the SRC meeting in its 395th meeting held on 25th - 26th February, 2021 considered the matter and decided as under:-

'The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee perused the matter of the institute and decided to write a letter to the institution with a copy to the affiliating body and State Govt. to make admission in the Government Teacher Training Institute, Chittur, Palakkad District, Kerala for the academic session 2020-2021.

The Committee also decided that an order to this effect be also uploaded in the SRC, Website immediately. Further a Show Cause Notice on standard 13 points be served on the institution for considering the issuance of RPRO."

- 6. NOW THEREFORE, the institution Government Teacher Training Institute, Chittur, Palakkad District, Kerala -678101 is allowed to conduct Elementary course of two years duration with an annual intake of 25 students in Malayalam Medium and 25 students in Tamil Medium for the academic session 2020 21 subject to fulfilment of the following conditions:
 - I. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
 - II. The institution shall make admissions only after it obtains affiliation form the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
 - III. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- **7**. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- **8**. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 9. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information regarding the following shall also be made available on the website namely:
 - a. Sanctioned programme(s) along with annual intake in the institution:
 - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - c. Name of faculty members who left of joined during the last, quarter:
 - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
 - e. Fee charged from students;
 - f. Available infrastructural facilities;
 - g. Facilities added during the last quarter;

- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information, if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- **10**. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 11. The institution shall make available the list of students admitted on its official website.
- 12. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations, and orders made or issued thereunder, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
