WHEREAS, the institution Our Lady College of Education, Our Lady Nagar, Maduravoyal, Chennai-602102, Tamilnadu was granted recognition vide SRC (NCTE) order no. F.TN/SEC/35/SRO/NCTE/2004-2005/8227 dated 02.11.2004 for conducting B.Ed. course of one year' duration with an annual intake of 100 students from the academic session 2004-2005

AND WHEREAS, after the promulgation of NCTE Regulations, 2014 and as per affidavits submitted by the institution on dt. 21.05,2015, the provisional revised recognition order was issued to the institution on 30.05.2015 for conducting B.Ed. course of two years' duration with an annual intake of 100 from the academic session 2015-16.

AND WHEREAS, in 314th meeting held on 27th & 28th May, 2016 the SRC taken general decision to cause inspection of such cases. Accordingly, as per the decision of SRC, a letter for inspection was sent on 14.06.2016 and the inspection was conducted. The institution has filed in respect of W.P.No.37585 of 2016.

AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the SRC in its 369th meeting held on 28.01.2019 and the committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, as per the decision a Show Cause Notice was issued to the institution on 13.08.2019.

AND WHEREAS, the institution has not submitted any documents as a result a Final Show Cause Notice was sent to the institution on 25.10.2019 as decided in 380th meeting held on 18th - 19th September, 2019 by Sub-Committee. Accordingly, the institution has submitted its reply along with documents dt.08.11.2019.

AND WHEREAS, the matter was placed before the SRC in its 384th meeting. The Committee considered the matter and decided to withdraw the recognition granted to the institution for B.Ed and M.Ed course on the basis of deficiencies mentioned therein. Accordingly, a Withdrawal order was issued on 27.02.2020 for B.Ed. The institution preferred an Appeal and the Appellate Authority vide its letter dt F.No.91-25th Mtg./2020-Appeal / 95193 dt 27.11.2020 considered the appeal and decided to Remand back the case of the institution. the institution has submitted its reply 01.12.2020 as directed by Appellate Authority.

AND WHEREAS, the matter was considered by the SRC in its 392nd meeting held on 15th-16th December 2020 as under: -

On the perusal of the reply submitted by the institution, the Committee decided that the continuation order be issued to the Institution Our Lady College of Education, Our Lady Nagar, Maduravoyal, Chennai602102, Tamilnadu for the following courses:

(i) B.Ed - 4 units (50 students each unit).

(ii) M.Ed-1 unit of 50 students."

NOW THEREFORE, the SRC decided to permit the institution i.e., Our Lady College of Education, Our Lady Nagar, S. No. 320/1B, 320/1C, 320/1E, 320/1F, 321/3 & 321/4, Maduravoyal, Chennai-602102, Tamilnadu for B.Ed. course run by Loordhu Ammal Educational Trust, (Our Lady College of Education), 1-A, Chari Street North Usman Street, T-Nagar, Chennai-600017 for continuation of recognition for B.Ed. course of two years duration with an annual intake of 200 students (four basic units) subject to fulfilment of the following conditions:

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually.

 Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- V. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 8. Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc. as applicable.
- 9. The institution shall submit to the Regional Committee a Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 10. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such

- 12. The institution shall make available the list of students admitted on its official website.
- 13. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
