WHEREAS, the institution S.M.R College of Education, Nataraj Nagar, Pudukottai Main Road, Mathur, Thiruvhirapalli District, Tamilnadu-620024 was granted recognition vide SRC (NCTE) order no. F.TN/SEC/SRO/NCTE/2005-2006/3915 dt. 09.11.2005 for conducting B.Ed. course of one year' duration with an annual intake of 100 students from the academic session 2005-2006. eri die deputin

AND WHEREAS, after the promulgation of NCTE Regulations, 2014 and as per affidavits submitted by the institution on dt. 20.01.2015, the provisional revised recognition order was issued to the institution on 01.05.2015 for conducting B.Ed. course of two years' duration with an annual intake of 100 from the academic session 2015-16.

AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the SRC in its 369th meeting held on 28.01.2019 and the committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, as per the decision a Show Cause Notice was issued to the institution on 27.02.2019. The institution submitted its reply along with documents on dt. 23.03.2019.

AND WHEREAS, the SRC in its 381st Meeting held on 31st October & 01st November 2019 considered the matter and decided to issue a final show cause notice. Accordingly, Final Show Cause Notice was issued to the institution on dt. 04.11.2019. Thereafter, a reply of Final Show Cause Notice was received on dt. 20.02.2020.

AND WHEREAS, the matter was placed before the SRC in its 386th meeting held on 23rd -24th July 2020, the Committee considered the matter and decided to withdraw the recognition granted to S.M.R College of Education, Nataraj Nagar, Pudukottai Main Road, Mathur, Thiruvhirapalli District, Tamilnadu-620024 for conducting B.Ed. course w.e.f. the 2020-21 academic session under clause 17(1) of NCTE Act, 1993. Accordingly, a withdrawal order was issued to the institution vide dt.30.07.2020. Thereafter, the institution preferred an appeal u/s 17 of NCTE Act, 1993 and the Appellate Authority vide order No. F.No.89-205/E-166099/2020 Appeal/27th Mtg.-2020/28th October 2020/95344 dt.07.12.2020 remanded back the matter to SRC.

AND WHEREAS, the institution has submitted its reply along with documents vide dated 14.12.2020 against the Order passed by the Appellant Authority.

AND WHEREAS, the matter was considered by the SRC in its 392nd meeting held on 15th-16th December 2020 as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:

On the perusal of the reply submitted by the institution, the Committee decided that the continuation order be issued to the Institution S.M.R College of Education, Nataraj nagar, Pudukottai Main road, Mathur, Thiruvhirapalli District, Tamil Nadu 620024 for B.Ed programme for 2 basic units of 50 students each unit."

NOW THEREFORE, the SRC decided to permit the institution i.e., S.M.R College of Education, Survey No.- 424/2, Nataraj Nagar, Pudukottai Main Road, Mathur, Thiruvhirapalli District, Tamilnadu-620024 for B.Ed. course run by Saraswathi Educational & Health Trust, Mathur Village, Pudukottai Main Road, Tiruchirapalli, Tamilnadu-620024 for continuation of recognition for B.Ed. course of two years duration with an annual intake of 100 students (two basic units) subject to fulfilment of the following conditions:

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- V. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 9. Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc. as applicable.
- 10. The institution shall submit to the Regional Committee a Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 11.
