WHEREAS, the institution Sri Balaji College of Education, Nagari, Ayyankottai Post, Vadapatti Taluk, Madurai District 625221, Tamil Nadu was granted recognition on dated 09.01.2009 for conducting B.Ed. course of one year' duration with an annual intake of 100 students. The permission for shifting of premises was hereby accorded by SRC to the institution on 27.02.2012.

AND WHEREAS, after the promulgation of NCTE Regulations, 2014 and as per affidavits submitted by the institution on dt. 20.01.2015, the provisional revised recognition order was issued to the institution on 18.03.2015 for conducting B.Ed. course of two years' duration with an annual intake of 100 from the academic session 2015-16.

AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the SRC in its 381st meeting held on 31st Oct & 01st November 2019 and the committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, a Show Cause Notice was issued on 07.09.2020. The institution has submitted its reply on 14.12.2020.

AND WHEREAS, the matter was considered by the SRC in its 392nd meeting held on 15th-16th December 2020 as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

On the perusal of the reply submitted by the institution, the Committee decided that the continuation order be issued to the Institution Sri Balaji College of Education, Nagari, Ayyankottai Post, Vadapatti Taluk, Madurai District 625221, Tamil Nadu for B.Ed programme for 2 basic units of 50 students each unit."

NOW THEREFORE, the SRC decided to permit the institution i.e., Sri Balaji College of Education, Survey No.- 126/1B, 126/2, 126/4, 127/2, 127/5B, 129/5F Nagari, Ayyankottai Post, Vadapatti Taluk, Madurai District 625221, Tamil Nadu for B.Ed. course run by Annai Meenakshi Educational and Charitable Trust, Madurai, Tamil Nadu for continuation of recognition for B.Ed. course of two years duration with an annual intake of 100 students (two basic units) subject to fulfilment of the following conditions:

I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
