WHEREAS, the institution Mahathma College of Education, Ariyur, Ariyur, Annavasal Road, Mathiyanallore Post, Illuppur Talum, Pudukkottai District, Tamilnadu was granted recognition vide SRC (NCTE) order no. F.SRO/NCTE/B.Ed./2006-2007/14927 dated 19.11.2007 for conducting B.Ed. course of one year' duration with an annual intake of 100 students from the academic session 2006-2007.

AND WHEREAS, after the promulgation of NCTE Regulations, 2014 and as per affidavits submitted by the institution on dt. 20.05.2015, the provisional revised recognition order was issued to the institution on 01.07.2015 for conducting B.Ed. course of two years' duration with an annual intake of 100 from the academic session 2015-16.

AND WHEREAS, the institution submitted its compliance of RPRO vide letter dt. 29.10.2015 which was considered by the SRC in its 317th Meeting held on 28th - 30th July 2016 wherein the institution was issued a letter regarding VT inspection. The institution was informed regarding inspection (for shifting of premise) vide letter dt. 13.09.2017 and depositing fee, but the inspection could not be carried out and the institution has also not responded. Here, it is also pertinent to mention that the institution is functioning on the land owned on 51 years' lease since grant of recognition and the deficiencies pointed in 317the meeting and mentioned above have not been communicated till date.

AND WHEREAS, the institution has not submitted any documents as a result a Final Show Cause Notice was sent to the institution on 04.12.2019 as decided in 381st meeting held on 31st October & 01st November, 2019 by Sub-Committee. Accordingly, the institution has submitted its reply along with documents dt. 18.12.2019.

AND WHEREAS, the SRC in its 383rd Meeting held on 07th & 09th January 2020 the matter was placed, and the Committee decided to Withdraw the Recognition to the institution. Accordingly, as per the decision Withdrawal Order was issued vide order no. F.SRC/NCTE/APSO7077/B.Ed./114500-4506 on dt. 19.03.2020. The Appellate Authority in NCTE vide order dt. 23.11.2020 remanded back the case of the institute to SRC. The institution has submitted its reply on 03.12.2020.

AND WHEREAS, the matter was considered by the SRC in its 392nd meeting held on 15th-16th December 2020 as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

On the perusal of the reply submitted by the institution, the Committee decided that the continuation order be issued to the Institution Mahathma College of Education, Ariyur, Ariyur, Annavasal Road, Mathiyanallore Post, IIIuppur Talum, Pudukkottai District, Tamilnadu for B.Ed programme for 2 basic units of 50 students each unit."

E-mail: src@ncte-india.org Website: www.srcncte.in NOW THEREFORE, the SRC decided to permit the institution i.e., Mahathma College of Education, Survey No.- 211/17, 211/18, Ariyur, Annavasal Road, Mathiyanallore Post, Illuppur Talum, Pudukkottai District, Tamilnadu for B.Ed. course run by Mahamuth Ammal Educational Trust, Pudukkottai District, Tamilnadu for continuation of recognition for B.Ed. course of two years duration with an annual intake of 100 students (two basic units) subject to fulfilment of the following conditions:

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- V. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 8. Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc. as applicable.
- The institution shall submit to the Regional Committee a Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 10. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. - The institution shall adhere to the mandatory disclosure in the prescribed format and 11. display up-to-date information on its official website.
- The institution shall make available the list of students admitted on its official website. 12. 13.
- The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
