### **ORDER**

WHEREAS, the recognition was granted to the institution, namely Sri Velavan College of Education, Survey No.228/3,5,6, College Road, Melpakkam Village, Ayyanthoppu Post, Near TNCC Godown, Tindivanam, Villupuram 604001, Tamil Nadu was granted recognition vide SRC (NCTE) order no. F.SRC/NCTE/2009/B.Ed./RO/9566 dated 24.02.2009 for conducting B.Ed. course of one year' duration with an annual intake of 100 students from the academic session 2009-2010.

AND WHEREAS, the Tamilnadu Teachers Education University had forwarded a copy of show cause notice issued to the institution for not functioning in accordance with the conditions stipulated by the NCTE, SRC, Bangalore and Tamilnadu Teachers Education University as could be apprehended from the report of Inspection commission which caused a surprise visit to the colleges.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dt. 26.01.2015 for its willingness of two units in B.Ed. course and adherence of provisions of new Regulations.

AND WHEREAS, provisional revised recognition order was issued to the institution on 01.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.

AND WHEREAS, the SRC in its 369th meeting held on 28.01.2019 considered the matters of the institutions which have not yet submitted compliance in respect of RPRO. Accordingly, a Show Cause Notice was issued to the institution on 16.09.2019. The institution has not yet submitted any reply.

AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the SRC in its 389th meeting and the committee decided that Final Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, a Final Show Cause Notice was issued on 16.10.2020. The institution has submitted its reply on 08.12.2020.

AND WHEREAS, the matter was placed before the SRC in its 392<sup>nd</sup> meeting held on 15<sup>th</sup> – 16<sup>th</sup> December, 2020 considered and decided as the following grounds:

"The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

On the perusal of the reply submitted by the institution, the Committee decided that the continuation order be issued to the Institution Sri Velavan College of Education, Shri Subramaniasamy Educational Trust, College Road, Melpakkam Village, Ayyanthoppu Post, Near TNCC Godown, Tindivanam, Villupuram 604001, Tamil Nadu for B.Ed. programme for 2 basic units of 50 students each unit."

NOW THEREFORE, this order is issued permitting the institution i.e. Sri Velavan College of Education, Survey No.228/3,5,6, College Road, Melpakkam Village, Ayyanthoppu Post, Near TNCC Godown, Tindivanam, Villupuram 604001, Tamil Nadu for continuation of recognition for B.Ed. programme for 2 basic units of 50 students each unit subject to fulfilment of the following conditions:

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 1. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc as applicable.
- 2. The institution shall submit to the Regional Committee a Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 3. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:-

- a. Sanctioned programme(s) along with annual intake in the institution:

- j. The institution shall be free to post additional relevant information, if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- The institution shall adhere to the mandatory disclosure in the prescribed format and 4. display up-to-date information on its official website.
- The institution shall make available the list of students admitted on its official website. 5.
- The institution shall fill the information on GIS Portal on the NCTE Website. 6.
