WHEREAS, the institution Sree Krishna College of Education, No. 69, Allarvelli Porayar Tharangambadi Taluk, Nagapattinam 609307, Tamil Nadu was granted recognition on dated 24.07.2009 for conducting B.Ed. course of one year' duration with an annual intake of 100 students.

ORDER

AND WHEREAS, after the promulgation of NCTE Regulations, 2014 and as per affidavits submitted by the institution on dt. 13.01.2015, the provisional revised recognition order was issued to the institution on 30.04.2015 for conducting B.Ed. course of two years' duration with an annual intake of 100 from the academic session 2015-16.

AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the SRC in its 388th meeting held on 14th – 15th September 2020 and the committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, a Show Cause Notice was issued on 29.09.2020. The institution has submitted its reply on 24.11.2020.

AND WHEREAS, the matter was considered by the SRC in its 392nd meeting held on 15th-16th December 2020 as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

On the perusal of the reply submitted by the institution, the Committee decided that the continuation order be issued to the Institution Sree Krishna College of Education, No. 69, Allarvelli Porayar Tharangambadi Taluk, Nagapattinam 609307, Tamil Nadu for B.Ed programme for 2 basic units of 50 students each unit."

NOW THEREFORE, the SRC decided to permit the institution i.e., Sree Krishna College of Education, Survey No. – 131-1, 132-1A, 132-2, 132-3, 132-4, 133, No. 69, Allarvelli Porayar Tharangambadi Taluk, Nagapattinam 609307, Tamil Nadu for B.Ed. course run by Sree Krishna educational and Charitable Trust, No. 10, Chidambara Nadir Street, Porayar, Nagapattinam, Tamil Nadu for continuation of recognition for B.Ed. course of two years duration with an annual intake of 100 students (two basic units) subject to fulfilment of the following conditions:

The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.

- v. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 6. Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc. as applicable.
