WHEREAS, the institution Sre Ramana College of Education Trust, Upparpatti Village & Post Office, Uthangarai Taluk, Krishnagiri District – 635207, Tamilnadu was granted recognition on dated 12.02.2014 for conducting B.Ed. course of one year' duration with an annual intake of 100 students.

AND WHEREAS, after the promulgation of NCTE Regulations, 2014 and as per affidavits submitted by the institution on dt. 15.01.2015, the provisional revised recognition order was issued to the institution on 11.03.2015 for conducting B.Ed. course of two years' duration with an annual intake of 100 from the academic session 2015-16. The institution vide letter dated 28.04.2015 pointed out a correction in the address of the institution. Accordingly, a Corrigendum was issued on 15.05.2015 correcting the address of the institution.

AND WHEREAS, the SRC in its 369th meeting held on 28.01.2019 and Committee decided that Show Cause Notice be issued to all such institution which have not submitted compliance. Accordingly, as per the decision of SRC a Show Cause Notice was issued to the institution on 26.09.2019. The institution has not submitted any reply in respect of Show Cause Notice.

AND WHEREAS, the SRC in its 380<sup>th</sup> meeting, a common decision was passed against the institution which have not submitted any reply of SCN a Final Show Cause Notice be issued to all such institutions. Accordingly, a Final Show Cause Notice was issued on 25.10.2019. The institution has not submitted any reply till date. The above matter was placed before the SRC in its 384<sup>th</sup> meeting. The Committee considered the matter and decided to withdraw the recognition of B.Ed course of the institution. Accordingly, a withdrawal order was issued to the institution on 25.02.2020. The institution preferred an appeal, and the Appellate Authority vide its order dt. 27.11.2020 remanded back the case of the institution with the direction to submit the compliance within 15 days as mentioned in the council's order. Now, the institution has submitted its reply on 02.12.2020.

**AND WHEREAS**, the matter was considered by the SRC in its 392<sup>nd</sup> meeting held on 15<sup>th</sup>-16<sup>th</sup> December 2020 as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

On the perusal of the reply submitted by the institution, the Committee decided that the continuation order be issued to the Institution Sre Ramana College of Education Trust, Upparpatti Village & Post Office, Uthangarai Taluk, Krishnagiri District – 635207, Tamilnadu for B.Ed programme for 2 basic units of 50 students each unit."

NOW THEREFORE, the SRC decided to permit the institution i.e., Sre Ramana College of Education Trust, Survey No.- 28/5A & 28/5B 2A, Upparpatti Village & Post Office, Uthangarai Taluk, Krishnagiri District – 635207, Tamilnadu for B.Ed. course run by Sre

- 8. The institution shall submit to the Regional Committee a Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 9. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
  - a. Sanctioned programme(s) along with annual intake in the institution:

- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 10. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 11. The institution shall make available the list of students admitted on its official website.
- 12. The institution shall fill the information on GIS Portal on the NCTE Website.
