CONTINUATION ORDER

WHEREAS, the recognition u/s 14(3)(a) of NCTE Act, 1993 was granted to the institution namely **Sree Konaseema Bhanoji Ramars College, East Godavari District, Andhra Pradesh** vide order No. F.AP/NEW/B.Ed./218/SRO/NCTE/2002-2003/6150 dated 26.03.2003 for conducting **Secondary (B.Ed.) Course** of one-year duration with an annual intake of 100 students from the academic year 2002-2003.

2. **AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution was submitted affidavit dated 02.02.2015 for its willingness & adherence of provisions of new Regulations. A Revised Provisional Recognition Order (RPRO) was issued to the institution on 12.05.2015 for conducting B.Ed. Programme of two years duration with an annual intake of 100 for two basic units of 50 students each from the academic session 2015-16.

3. **AND WHEREAS**, the matter was considered by SRC in its 363rd meeting held on 17th to 19th September 2018 and the Committee decided to issue a Show Cause Notice. As per the decision of SRC, a Show Cause Notice was issued on 17.10.2018. The institution has not submitted reply of Show Cause Notice.

4. **AND WHEREAS**, the SRC in its 393rd meeting held on 5th – 6th January 2021 considered the matter and decided to issue Final Show Cause Notice to the institution. Accordingly, as per the decision of SRC, a Final Show Cause Notice was issued to the institution on 08.01.2021. The institution has submitted its reply on 25.01.2021.

5. **AND WHEREAS**, the SRC in its 395th meeting held on 25th – 26th February, 2021 has considered the matter and decided to issue a last reminder letter. Accordingly, as per the decision of SRC, a Last Reminder Letter was issued to the institution on 15.03.2021. The institution vide dated 19.01.2022 was submitted reply in response to the Last Reminder Letter.

6. **AND WHEREAS**, the SRC in its 408th Meeting held on 02nd March, 2022 considered the matter and decided to withdraw the recognition. Accordingly, as per the decision of SRC, a Withdrawal Order No. F.SRO/NCTE/APSO0311/B.Ed./{KA}/2022/130728-130731 was issued to the institution on 14.03.2022.

7. **AND WHEREAS**, aggrieved by the Withdrawal Order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order No. 89-135/E-254630/2022 Appeal/9th Meeting, 2022 APPLSRC202214362 dated 30.11.2022 appeal remand back the order appealed against. The institution has submitted reply of appeal remand back case dated 14.12.2022.

8. **AND WHEREAS**, the SRC in its 419th meeting held on 13th January 2023 considered the matter and decided to issue a Final Show Cause Notice. Accordingly, as per the decision of SRC, a Final Show Cause Notice was issued to the institution on 01.02.2023. The institution vide letter dated 14.02.2023 has submitted a reply to the Final Show Cause Notice.

9. **AND WHEREAS**, the SRC in its 422nd meeting held on 02nd – 03rd March 2023 considered the matter and decided as under:-

“The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Sree Konaseema Bhanoji Ramars College, Amalapuram, Revenue Division, Amalapuram, East Godavari District-533201, Andhra Pradesh for B.Ed. programme for 1 basic unit of 50 students”.

10. **NOW THEREFORE**, this order is issued permitting the institution i.e. **Sree Konaseema Bhanoji Ramars College, Amalapuram, Revenue Division, Amalapuram, East Godavari District-533201, Andhra Pradesh** for continuation of recognition for B.Ed. Programme for two-years duration with an annual intake of **1 basic unit of 50 students** subject to fulfilment of the following conditions:-

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.



11. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.

12. The institution shall submit to the Regional Committee as Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

13. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:-

- a. Sanctioned programme(s) along with annual intake in the institution:
- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c. Name of faculty members who left or joined during the last, quarter:
- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- e. Fee charged from students;
- f. Available infrastructural facilities;
- g. Facilities added during the last quarter;
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

14. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.

15. The institution shall make available the list of students admitted on its official website.

16. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made or issued there under, the institution will render itself



vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provision of Section 17(1) of the NCTE Act, 1993.
