ORDER

WHEREAS, recognition was granted to the institution namely Nalanda College of Education, Adoni Revenue Division, Yemmiganur, Kurnool District-518360, Andhra Pradesh run by VBT Educational Society, HBS Colony, Yemmiagnaur, Kurnool District-518360, Andhra Pradesh vide SRC (NCTE) order no. F.AP/NEW/B.Ed/104/SRO/NCTE/2002-2003/6138 dt. 03.03.2003 for conducting B.Ed. course of one-year duration with an annual intake of 100 students.

AND WHEREAS, on scrutiny, it is found that recognition of the institution was withdrawn on 22.10.2008 and the same was confirmed by the appellate authority vide order dated 09.02.2009. The institution has approached the Hon'ble Court in W.P. No. 5509 of 2009 and the Hon'ble court has granted an interim suspension of the proceedings of the appellate authority and SRC, NCTE.

AND WHEREAS, the SRC in its 286th meeting held on 30th April, 2015 considered the VT report and other documents and decided to issue show cause notice for Building Plan, Building completion certificate and approved staff list. Before issuance of show cause notice, the institution submitted a reply based on website information on 14.05.2015.

AND WHEREAS, the SRC in its 289th meeting held on 23rd June, 2015 considered the reply submitted by the institution and decided as under:-

- 1. "Affidavit submitted.
- 2. RPRO issued
- 3. Permit shifting
- 4. Ensure adherence to 2014 norms before 31.10.2015."

AND WHEREAS, a order no. F.SRO/APSO0172/B.Ed/AP/2015/69241 dt. 02.07.2015 (P-1464/coors was issued to the institution allowing shifting to new location/building at Nalanda College of Education, Sy. No. 1156 & 1159 B,Yemmiganur to Adhoni Road, Hanumapuram, Kurnool District, Andhra Pradesh for conducting B.Ed. course of two years duration with an annual intake of100 (Two basic units) from the academic session 2015-16 subject to fulfillment of following conditions:-

(i) The institution shall submit revalidated FDRs of the enhanced values, in joint account with the SRC before 30 June, 2015 failing which recognition will be withdrawn.

- (ii) The institution shall create additional facilities that include (a) additional built-up area, (b) additional infrastructure, (c) additional founds, (d) additional staff as per Regulations, 2014 and inform Regional Committees with required documents by October 31, 2015.
- (iii) The applicant-institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), land Use Certificate (LUC), Building Plan (BP) and the Approved Staff List in the specified Performa available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building Completion Certificate (BCC) may be given along with order documents if available, otherwise it can also be given to the Visiting team at the time of inspection.
- (iv) The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these conditions by 20 Feb, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.

AND WHEREAS, the institution vide letter dated 26.06.2019 submitted reply to the RPRO reply. In the matter of W.P. No. 5509 of 2009 filed by Nalanda College of Education Vs. NCTE, the matter was disposed of vide order dated 25.02.2016 (Corres. Pg. 1736) and the Hon'ble High Court directed.

AND WHEREAS, the SRC in its 378th meeting held on 25th & 26th July, 2019 considered the matter and decided as under;

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

On the perusal of the original documents and records made available in the file. The Committee decided that to issue Final Show Cause Notice for B.Ed programme on the following grounds: -

(i) The institution submitted staff list verified by Dean, College Development Council, Rayalaseema University, Kurnool who is not the competent authority to approve the staff list. The institution is required to submit Staff list duly approved by the Registrar of the affiliating body as per the prescribed Format.

Therefore, the Committee decided to issue Final Show Cause Notice u/s 17 of NCTE Act, 1993 before withdrawal of the recognition on the grounds mentioned above to the institution. The institution is required to submit the documents within 21 days from the date of issue of Final Show Cause Notice.

AND WHEREAS, as per the decision of SRC a Final Show Cause Notice was issue to the institution on 30.07.2019. The institution vide letter dated 05.08.2019 submitted its reply to the Final Show Cause Notice. The SRC in its 379th meeting held on 21st – 22nd August, 2016 considered the matter and decided as under:-

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

On the perusal of the original documents and records made available in the file. The Committee decided that the continuation order be issued to Nalanda College of Education, Adoni Revenue Division, Yemmiganur, Kurnool District-518360, Andhra Pradesh for B.Ed programme for 2 units (50 students each unit).

- 5. NOW THEREFORE, this order is issued permitting the institution i.e. Nalanda College of Education, Sy. No. 1156 & 1159B, Yemmiganur to Adhoni Road, Hanumapuram, Kurnool District-518360, Andhra Pradesh run by Vaidyam Basappa Thippamma Educational Society, D.No. 1/1515, Ganghinaga, Yemmiagnaur, Kurnool District-518360, Andhra Pradesh for continuation of recognition for B.Ed course of two years duration with an annual intake of 100 students (two units) of 50 each subject to fulfillment of the following conditions:
 - I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
 - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
 - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
 - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- **6.** Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc as applicable.
- 7. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 8. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
 - a. Sanctioned programme(s) along with annual intake in the institution:
 - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - c. Name of faculty members who left of joined during the last, quarter:

- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- e. Fee charged from students;
- f. Available infrastructural facilities;
- g. Facilities added during the last quarter;
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information, if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 9. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 10. The institution shall make available the list of students admitted on its official website.
- The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
