WHEREAS, the institution namely Sri Jayajothi College of Education, Door No.7B, PavadiMuniyappanKoil Street, 10th Ward, Tharamangalam Salem District – 636502, Tamilnaduwas granted recognition for conducting B.Ed. course of one years' duration with an annual intake of 100 students from the academic session 2005-2006 vide SRC, NCTE's vide order no. F.TN/SEC/SRO/NCTE/2005-2006/839 dt.13.07.2005.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dt.19.01.2015for its willingness of two units in B.Ed. course and adherence of provisions of new Regulations.

AND WHEREAS, revised provisional recognition order was issued to the institution on 13.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.

AND WHEREAS, the matter was placed before the SRC in its 375th meeting held on 13th – 14thMay, 2019 wherein the Committee considered the matter and decided as under:

"The Committee decided to withdraw the recognition granted to Sri Jayajothi College of Education, Door No.7B, PavadiMuniyappanKoil Street, 10th Ward, Tharamangalam Salem District — 636502, Tamilnadu for conducting B.Ed. course as the institution has not submitted any reply to the Show Cause Notice dt.17.02.2017."

AND WHEREAS, as per the decision of SRC, withdrawal order was issued to the institution vide dt.03.06.2019.

AND WHEREAS, the institution preferred an appeal u/s 18 of NCTE Act, 1993 and the Appellate Authority vide order No. 89-226/E-120840/2019 Appeal/21st Mtg.-2019/9th July, 2019 dt.30.07.2019 remanded back the matters of Additional Intake in B.Ed. courses respectively to SRC. The operative part of the orders is as under: -

Operative part of Order No. 89-226/E-120840/2019 Appeal/21st Mtg.-2019/9th July, 2019 dt.30.07.2019 in respect of additional intake in B.Ed. course: -

"AND WHEREAS, Appeal Committee, therefore, is convinced with the appellant's logic that without having received the SCN, it was not possible for them to have replied to the SCN. Appeal Committee decided to set aside the impugned order of withdrawal dated 03.06.2019. SRC is required to reissue the SCN and ensure its delivery to appellant institution at correct address. Appellant institution on receipt of SCN will be required to submit suitable reply to SRC which in turn is to be examined and case revisited accordingly.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing, Appeal Committee concluded to set aside the impugned order of withdrawal dated 03.06.2019. SRC is required to reissue the SCN and ensure its delivery to appellant institution at correct address. Appellant institution on receipt of SCN will be required to submit suitable reply to SRC which in turn is to be examined and case revisited accordingly.

NOW THEREFORE, the Council hereby remands back the case of Sri JayajothiCollege of Education, Salem, Tamilnadu to the SRC, NCTE, for necessary action as indicated above."

AND WHEREAS, the institute had submitted its reply on 06.08.2019 along with the documentsThe SRC in its 379^{th} meeting held on $21^{st}-22^{nd}$ August 2019 considered the reply submitted by the institution and decided as under: -

"On the perusal of the original documents and records made available in the file, the Committee decided that the continuation order be issued to Sri Jayajothi College of Education, Door No.7B, PavadiMuniyappanKoil Street, 10th Ward, Tharamangalam Salem District – 636502, Tamilnadu for B.Ed programme for 2 unit (50 students each unit)"

NOW THEREFORE, this order is issued permitting the institution Sri Jayajothi College of Education, Door No.7B, PavadiMuniyappanKoil Street, 10th Ward, Tharamangalam Salem District - 636502, Tamilnadurun by Vettrivel Health & Educational Trust for continuation of conducting B.Ed course of two years duration with an intake of 100 students (two basic units of 50 students each) subject to fulfilment of the following conditions:

- The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation form the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 6. Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc as applicable.
- 7. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 8. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as

land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:-

Sanctioned programme(s) along with annual intake in the institution:

b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.

c. Name of faculty members who left of joined during the last, quarter:

d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;

e. Fee charged from students;

Available infrastructural facilities;

g. Facilities added during the last quarter;

h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;

i. The affidavit with enclosure submitted along with application.

The institution shall be free to post additional relevant information, if it so desires.

- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- The institution shall adhere to the mandatory disclosure in the prescribed format and 9. display up-to-date information on its official website.
- The institution shall make available the list of students admitted on its official website. 10.
- The institution shall fill the information on GIS Portal on the NCTE Website. If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made or issued thereunder, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993. Also order that a copy of this Order be published in the official Gazette.
