WITHDRAWAL ORDER

WHEREAS, the recognition was granted to the institution namely, P.D.R. Vellachiammal College of Education, Sekkampatti, Soriampatti-636902, Dhamapuri District, Tamilnadu vide SRC order No. F.TN/SEC/149/SRO/NCTE/2004-2005/7143 dated 09.09.2004 for conducting Secondary (B.Ed.) course of one-year duration with an annual intake of 100 students from the academic session 2004-2005.

2. AND WHEREAS, after promulgation of NCTE Regulations, 2014, the institution has consented to come under new Regulations notarized affidavit dated 30.05.2015. A revised provisional recognition order was issued to the institution on 03.07.2015 for conducting B.Ed. programme of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.

3. AND WHEREAS, the SRC in its 320th meeting held on 19th – 20th September 2016 has considered the matter and decided to issue Show Cause Notice. Accordingly, a Show Cause Notice was issued to the institution on 15.10.2016. The institution vide letter dated 08.11.2016 has submitted reply to the Show Cause Notice.

4. AND WHEREAS, the SRC in its 395th meeting held on 25th – 26th February 2021 has considered and decided to issue Final Show Cause Notice. Accordingly, a Final Show Cause Notice was issued to the institution on 08.03.2021. The institution vide letter dated 05.04.2021 has submitted reply to the Final Cause Notice.

5. AND WHEREAS, the SRC in its 400th meeting held on July 13th – 14th, 2021 considered the matter and decided as follows: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The institution was issued a Final Show Cause Notice (FSCN). The institution has submitted its reply vide dated 05.04.2021. The Committee observed the reply submitted by the institution and found the following deficiencies.

- The institution had failed to remove the deficiencies communicated vide Notice dated 23.03.2011 for the following: -
 - The management is running Two Teacher Training Institutions in the same building, and no earmarked built-up area for each of the course/ programme. The total built-up area is 20621 sq.ft. which is inadequate for both B.Ed. and D.T.Ed.

- No exclusive Land and Building has been exclusively earmarked for each Teacher Education Programme and for other programmes.
 - No clear/ exclusive earmarking of built-up area there for each of the programmes being run in the same premises. A school is also functioning in the same building/premises, which is against the NCTE Norms.
 - To submit the documents for having deposited the Endowment Fund and Reserve Fund of Rs. 5 lakhs and 3 lakhs respectively for each course separately.
 - The latest Building Completion Certificate from the Competent Government Engineer has not been submitted in the proper format.
- The institution had also failed to remove the following deficiencies communicated vide notice dated 08.03.2021: -
 - The institution has submitted a photocopy of BUILDING COMPLETION CERTIFICATE instead of Notarized copy of it.
 - As per NON - ENCUMBRANCE CERTIFICATE, the land is of agricultural nature. Hence, LAND USE CERTIFICATE cannot be relied upon.
 - Deficiencies communicated vide SCN dt. 22.03.2021 has not been removed by the institute.

Hence, the Committee decided to **withdraw the recognition** granted to **P.D.R. Vellachiammal College of Education, Sekkampatti, Soriampatti-636902, Dhamapuri District, Tamilnadu** for conducting **B.Ed. programme** with effect from the academic session i.e. 2021-2022 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above".

6. **NOW THEREFORE**, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to **P.D.R. Vellachiammal College of Education, Sekkampatti, Soriampatti-636902, Dhamapuri District, Tamilnadu** run by **Madras Education and Research Integrated Trust, 23, Josier Street, Nungambakkam, Chennai-600034, TamilNadu** for conducting **B.Ed. programme** of two years duration with an annual intake of 100 students (2 basic units) w.e.f. the next academic session i.e., 2021-2022 onwards.

7. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or

University, or in any school, College or other Educational Body aided by the Central Government or any State Government.”

8. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through “online mode” available on NCTE’s website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE’s website.
