WHEREAS, the recognition was granted to the institution J.K College of Education, J.K Nagar, Dindigul District, TamilNadu vide SRC order No.F.SRO/NCTE/B.Ed./2006-2007/7116 dt. 27.07.2007 for conducting Secondary (B.Ed.) course of one-year duration with an annual intake of 100 students.

- AND WHEREAS, the SRC vide order no.F.NO.APS04661/B.Ed./TN/2011-12/40718 dated 03.05.2012 was issued to the institution for shifting of premises to new location / building at J.K. Teacher Training Institute & J.K. College of Education, NH-7, Madurai Road, Begampur Post, Dindigul - 02, TamilNadu.
- AND WHEREAS, after promulgation of NCTE Regulations, 2014, the institution has consented to come under new Regulations notarized affidavit dated 11.02.2015. A revised provisional recognition order was issued to the institution on 14.05.2015 for conducting B.Ed. programme of two years duration with an annual intake of 100 (Two basic units) from the academic session 2015-16.
- AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the SRC in its 369th meeting held on 28.01.2019 and the Committee decided to issue a Show Cause Notice. Accordingly, a Show Cause Notice was issued to the institution on 28.08.2019. The institution has not submitted reply to the Show Cause Notice.
- 5. AND WHEREAS, the SRC in its 380th meeting held on 18th - 19th September, 2019 has considered the matter and decided to issue Final Show Cause Notice in all such matters where the institution has not submitted the following requisite documents/VT report not accompanied with the requisite documents. Accordingly, a Final Show Cause Notice was issued to the institution on 17.10.2019. The institution vide letter dated 07.11.2019 has submitted reply to the Final Show Cause Notice.
- AND WHEREAS, the SRC in its 400th meeting held on July 13th 14th, 2021 considered the matter and decided as follows: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The institution was issued a Final Show Cause Notice (FSCN). The institution has submitted its reply vide dated 07.11.2019. The Committee observed the reply submitted by the institution and found the following deficiencies.

- 1. The institution has submitted a self-attested photocopy of all documents which are mentioned in Final Show Cause Notice instead of Notarized copy of these document.
- The institution has submitted a photocopy of NEC in regional language. The institution is required to submit an English Translated & Notarized copy of NEC.
- 3. The institution has submitted a photocopy of Building Plan which is neither readable nor approved. The institution is required to submit a Notarized copy of Building Plan.
- 4. The institution has submitted a photocopy of BCC in which Built-up area is mentioned as 21497 sqft. / 1997.14 sqm. which is not sufficient as per NCTE Norms.
- 5. The institution has not appointed Faculty for Fine Arts & Performing Arts as per NCTE Regulations, 2014. The faculty appointed by the institution for 2 basic unit of B.Ed. as 1 + 11 against the requirement of 1 + 15 as per NCTE Norms
- 6. Separate staff list not submitted for B.Ed. and M.Ed. courses.

Hence, the Committee decided to withdraw the recognition granted to J.K. College of Education, NH-7, Madurai Road, Begampur Post, Dindigul-624002, TamilNadu for conducting B.Ed. & M.Ed. programmes with effect from the academic session i.e. 2021-2022 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above".

- 7. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to J.K. College of Education, NH-7, Madurai Road, Begampur Post, Dindigul-624002, TamilNadu run by Vedasandur Rajathiammal and Rengaswamy Chettiar Trust, Dindigul District-624002, TamilNadu for conducting B.Ed. programme of two years duration with an annual intake of 100 students (2 basic units) w.e.f. the next academic session i.e., 2021-2022 onwards.
- 8. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

9. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
