WHEREAS, in terms of Section 14(1) of the NCTE Act, Ponnur Educational Development Society, Plot No. 335-1, GBC Road, Ponnur Village & P.O, Ponnur Taluk & City, Prakasam District-522124, Andhra Pradesh had applied for grant of recognition to Sri Venkateswara College of Education, Plot No. 335-1, G B C Road, Nidubrolu Village, Ponnur P.O, Taluk & City, Guntur District-522124, Andhra Pradesh for B.Ed course online on 26.05.2015 for two years duration under section 14(1) of the NCTE Act, 1993 and hardcopy received by Southern Regional Committee of NCTE on 08.06.2015.

AND WHEREAS, on scrutiny of the application submitted by the institution, the documents attached therewith, the affidavit submitted the report received from VT and videography thereof and the certificates received from the university, the Committee is satisfied that the applicant fulfils the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the said teacher education programme such as instructional facilities, infrastructural facilities, financial resources, etc., for running the programme.

NOW THEREFORE, in exercise of the powers vested under Section14(3) (a) of the NCTE Act, 1993, the Regional Committee, NCTE hereby grants recognition to Sri Venkateswara College of Education, Plot No. 335-1, G B C Road, Nidubrolu Village, Ponnur P.O, Taluk & City, Guntur District-522124, Andhra Pradesh for conducting B.Ed programme of two years duration with an annual intake of 100 students (2 units) from the academic sessions 2017-2018 under Clause 7(16) of NCTE (Recognition Norms & Procedure) Regulations, 2014 subject to fulfillment of the following conditions:-

- I. The Endowment fund of Rs.5 lakhs and Reserve fund of Rs.7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Loan raising against or mortgaging of FDR's shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- III. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- Further, the recognition is subject to fulfillment of all such other requirements as may be
 prescribed by other regulatory bodies like UGC, affiliating University / Body, the State Government
 etc, as applicable.
- 3. The institution shall submit to the Regional Committee a Self- Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 4. The institutions shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter –alia, the details of the institution, its location, name of the programme applied for with intake; availability of physical infrastructure, such as land, building, office, classrooms, and other facilities or amenities; instructional facilities, such as laboratory and library and the particulars of their proposed teaching faculty and non-teaching staff with photographs, for information of all concerned.
