WHEREAS, recognition u/s 14 (3)(a) of NCTE Act, 1993 was granted to the institution namely, Sri Venkateswara College of Education, Survey No. 335-1, Nidubrolu Village, Ponnur, Guntur District – 522124, Andhra Pradesh vide order no. F.SRO/NCTE/SRCAPP2413/B.Ed./AP/2016-2017/93127 dt. 02.05.2017 for B.Ed. Programme of two years duration with annual intake of 2 units of 50 students each from the academic sessions 2017-2018.

- 2. AND WHEREAS, the SRC in its 408<sup>th</sup> Meeting held on 02<sup>nd</sup> March, 2022 taken a decision to issue Show Cause Notice to all the colleges of teacher education established even after NCTE Regulations, 2014 at the earliest in order to ascertain the compliance of NCTE Regulations, 2014. Accordingly, as per decision of SRC Show Cause Notice was issued to the institution on 15.11.2022. The institution has submitted its reply on 29.11.2022.
- 3. AND WHEREAS, the SRC in its 418<sup>th</sup> Meeting held on 16<sup>th</sup> December, 2022 considered the matter and decided as follows: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Sri Venkateswara College of Education, Survey No. 335-1, Nidubrolu Village, Ponnur, Guntur District – 522124, Andhra Pradesh for B.Ed. programme, 2 basic units of 50 students each.

The Committee further decided that the above said decision will be subject to the outcome of writ petition pending before the Hon'ble High Court of Delhi in respect of Performance Appraisal Report (PAR)."

- 4. NOW THEREFORE, this order is issued permitting the institution i.e., Sri Venkateswara College of Education, Survey No. 335-1, Nidubrolu Village, Ponnur, Guntur District 522124, Andhra Pradesh for Continuation of recognition for B.Ed. programme for two years duration with an annual intake of 2 basic units of 50 students each subject to the outcome of writ petition pending before the Hon'ble High Court of Delhi in respect of Performance Appraisal Report (PAR) and fulfilment of the following conditions:-
  - I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
