WHEREAS, the recognition u/s 14(3)(a) of NCTE Act, 1993 was granted to the institution namely S S Mahita College of Education, Plot No. 280/1, Steet No. 1, Ganguru Village & Post Ganguru Town, Penamaluru Taluk, Krishna District — 521139, Andhra Pradesh run by Sri Vishnavi Educational Sports Development Society, Plot No. 40-5-5/4, Adikari Hotel Lane Tikkle Road, Vijayawada Village and Post, Vijayawada Taluk and City, Krishna District — 520010, Andhra Pradesh vide order No. F. SRO/NCTE/SRCAPP2284/B.Ed./AP/2017-2018/93138 dated 02.05.2017 for conducting B.Ed. programme of two-years duration intake of 100 students (two units) from the academic session 2017-2018.

- 2. AND WHEREAS, the SRC in its 408th Meeting held on 02nd March, 2022 has taken the decision to issue Show Cause Notice to all the colleges of teacher education established even after NCTE Regulations, 2014 at the earliest in order to ascertain the compliance of NCTE Regulation, 2014. Accordingly, as per the decision of SRC, a Show Cause Notice was issued to the institution on 02.01.2023. The institution has submitted a reply of Show Cause Notice dt. 05.01.2023.
- 3. AND WHEREAS, the SRC in its 431st meeting held on 10th January, 2024 considered the matter and decided as under:-

"The original file of the Institution alongwith other related documents, NCTE Act 1993, Regulations, Guidelines issued by NCTE from time to time, the SRC after careful consideration made the following observations: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution SS Mahita College of Education, Survey No. 280/1, D.No. 6-226/4, Ganguru Village, Penamaluru Mandal, Krishna District – 521139, Andhra Pradesh for B.Ed. programme 2 basic units of 50 students each."

- 4. NOW THEREFORE, this order is issued permitting the institution i.e. SS Mahita College of Education, Survey No. 280/1, D.No. 6-226/4, Ganguru Village, Penamaluru Mandal, Krishna District 521139, Andhra Pradesh for continuation of recognition for B.Ed. Programme for two-years duration with an annual intake of (2 basic units) of 50 students each subject to fulfilment of the following conditions:-
 - The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.

II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.

 - f. Available infrastructural facilities;
 - g. Facilities added during the last quarter;
 - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
 - i. The affidavit with enclosure submitted along with application.
 - j. The institution shall be free to post additional relevant information if it so desires.
 - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
