# TO BE PUBLISHED IN GAZETTE OF INDIA PART III SECTION 4 WITHDRAWAL ORDER

WHEREAS, the recognition was granted to the institution namely KBR College of Education, Santhi Vanam, 7<sup>th</sup> Ward, Narasareddy Kandriga, Naidupet Mandal, Nellore District, Andhra Pradesh run by KSR Memorial Charitable Trust for Rural Development, Hyderabad, Andhra Pradesh vide SRC (NCTE) order No F. SRC/APSO9335/B.Ed./AP/2012/45683 dated 30.08.2012 for conducting B.Ed. Course of one-year duration with an annual intake of 100 students from the academic session 2012-2013.

- 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution had submitted affidavit dated 21.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on14.05.2015 for conducting B.Ed. Programme of two years duration with an annual intake of 100 (Two basic units) from the academic session 2015-16.
- 3. AND WHEREAS, the SRC in 369<sup>th</sup> Meeting held on 28.01.2019 considered the matter and decided to issue SCN in all such matters where the institution has not submitted the following requisite documents/VT Report accompanied with requisite documents in respond to RPRO issued by the SRC. Accordingly, as per decision a Show Cause was issued to the institution on 15.02.2019.
- 4. AND WHEREAS, as per decision taken by Committee on SRC 381<sup>st</sup> Meeting held on 31<sup>st</sup> Oct & 01<sup>st</sup> November a Final Show Cause Notice was issued to the institution on dated 29.11.2019. The institution has submitted reply of Final Show Cause Notice on 02.01.2020.
- 5. AND WHEREAS, the SRC in its 400<sup>th</sup> Meeting held on 13<sup>th</sup> & 14<sup>th</sup> July, 2021 considered the matter and decided as under:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The institution was issued a Final Show Cause Notice (FSCN). The institution has submitted its reply on 02.01.2020. The Committee observed the reply submitted by the institution and found the following deficiencies.

1. The institution has submitted notarized photocopy of in which total built-up area not mentioned, approving authority seal not readable and area of multipurpose hall less than 2000sqft.

2. The institution has submitted notarized photocopy of site plan in which total

site area is not mentioned.

3. The institution has submitted Building Completion Certificate in which area of

multipurpose hall is not mentioned.

4. The institution has submitted xerox copy of FDRs of Rs. 5 Lakhs & Rs. 3 Lakhs which was matured on 08.09.2020. The institution has not submitted For, 'A' (original) towards proof of joint FDRs in a scheduled book with SRC, NCTE towards endowment Fund & Reserve Fund sum of Rs. 5 lakhs and 7 lakhs respectively.

5. The institution has submitted staff list which is not approved by affiliating

body

(i) The institution has submitted in which SL No. SK. Sharmila Bhanu, SL No. 16 T. Ramurthy does not have NET/Ph.D. as per NCTE (Recognition Norms & Procedure) (Amendment) Regulations, 2017 dated 29.05.2017 notified on 09.06.2017.

(ii) The institution has not submitted the latest faculty list approved by

affiliating body."

Hence, the Committee decided to withdraw the recognition granted to KBR College of Education, Santhi Vanam, 7<sup>th</sup> Ward, Narasareddy Kandriga, Naidupet Mandal, Nellore District, Andhra Pradesh for conducting B.Ed. course with effect from the academic session i.e. 2021-2022 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above."

6. NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of KBR College of Education, Santhi Vanam, 7<sup>th</sup> Ward, Narasareddy Kandriga, Naidupet Mandal, Nellore District, Andhra Pradesh run by KSR Memorial Charitable Trust for Rural Development, Hyderabad, Andhra Pradesh for B.Ed. Programme with effect from the next academic session i.e. 2021-2022 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education

immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website <a href="www.ncte-india.org">www.ncte-india.org</a> within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
