WHEREAS, the recognition was granted to the institution namely Venkata Surya College of Physical Education, Plot No. 108/1,2,3,4,7, 669/7, Kalavarai Village, Bobbili Taluka, Vizianagaram District, Andhra Pradesh run by Uma General Technical & Medical Educational Society, Kalavarai Bobbili, Vizianagaram District Andhra Pradesh vide SRC (NCTE) order No SRCAPP425/ B.P.Ed/AP2011-2012/29274 dated 30.06.2011 for conducting B.P.Ed. Course of oneyear duration with an annual intake of 100 students from the academic session 2011-12.

- AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dated 21.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 19.05.2015 for conducting B.P.Ed. Programme of two years duration with an annual intake of 100 (Two basic units) from the academic session 2015-16.
- AND WHEREAS, the management of the institution has submitted request vide letter on 20.10.2017 for closure of B.P.Ed. Programme granted to the above said institution.
- AND WHEREAS, the SRC in its 400th Meeting held on 13th & 14th July, 2021 considered the matter and decided as under:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee agreed to close down the institution as requested by the management on 20.10.2017 by withdrawing the recognition granted to Venkata Surya College of Physical Education, Plot No. 68/1,2,3,4, 69/7, 8, 9, 10p, 69/3p, 69/6p, Kalavarai Village, Bobbili Taluka, Vizianagaram District, Andhra Pradesh for conducting B.P.Ed. programme under clause 17(1) of NCTE Act, 1993 from the academic session 2021-2022.

However, the FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director on the submission of the following:

- (a) NOC from the affiliating body.
- (b) NOC from the staff/faculty.
- (c) Resolution of the management to the effect for closure of the course".
- NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of Venkata Surya College of Physical Education, Plot No. 108/1,2,3,4,7, 669/7, Kalavarai Village, Bobbili Taluka, Vizianagaram District. "If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
