WHEREAS, the recognition was granted to the institution namely, Gopi Krishna D.Ed. College, Plot No.5/5, GKHS Road, Dorasanipalle Village and Post, Proddatur Taluk and City, Kadapa District-516360, Andhra Pradesh run by Gopikrishna Educational Society, Plot No.S.No.5/5, GKHS Road, Dorasanipalle Village and Post, Proddatur Taluk and City, Kadapa District-516360, Andhra Pradesh vide SRC (NCTE) order No SRCAPP1271/D.El.Ed. /AP/2012/45647 dated 29.08.2012 for conducting D.El.Ed. Course of two-years duration with an annual intake of 50 students from the academic session 2012-2013.

- 2. AND WHEREAS, the institution vide letter dated 10.06.2020 has submitted a written representation for requesting to permission to close the institution from the academic year 2019-2020.
- 3. AND WHEREAS, the SRC in its 400<sup>th</sup> Meeting held on 13<sup>th</sup> & 14<sup>th</sup> July, 2021 considered the matter and decided as under:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee agreed to close down the institution as requested by the management on 10.06.2020 by withdrawing the recognition granted to Gopikrishna D.Ed College, Plot No. 5/5, GKHS Road, Dorasanipalle Village and Post, Proddatur Taluk and City Kadapa District-516360, Andhra Pradesh for conducting D.El.Ed. programme under clause 17(1) of NCTE Act, 1993 from the academic session 2021-2022.

However, the FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director on the submission of the following:

- (a) NOC from the affiliating body.
- (b) NOC from the staff/faculty.
- (c) Resolution of the management to the effect for closure of the course."
- 4. NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of Gopikrishna D.Ed College, Plot No. 5/5, GKHS Road, Dorasanipalle Village and Post, Proddatur Taluk and City Kadapa District-516360, Andhra Pradesh run by Sri Gopi Krishna Educational Society, Proddatur-516360, Cuddapah District, Andhra Pradesh for D.El.Ed. Programme with effect

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website <a href="https://www.ncte-india.org">www.ncte-india.org</a> within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
