WHEREAS, the recognition was granted to the institution namely, Penuballi Ramakrishnaiah College of Elementary Education, No. 1, 1st Street, Kodavalur Village, Post & Taluk, Nellore District-524316, Andhra Pradesh run by Penuballi Ramakrishnaiah Educational Society, No. 1, Golden Nagar Road, Kodavalur Village, Post & Taluk, Nellore District-524316, Andhra Pradesh vide SRC (NCTE) order No SRCAPP1533/D.EI.Ed/AP/2012/46260 dated 18.09.2012 for conducting D.EI.Ed. Course of two-year duration with an annual intake of 50 students from the academic session 2012-2013.

- 2. AND WHEREAS, a letter No. RC.No. 359/A/SCERT/2019 dated 29.6.2020 is received from the Commissioner, School Education (FAC), School Education Department, Govt. of Andhra Pradesh on 17.07.2020 recommending therein for derecognition order in respect of 188 Pvt. D.El.Ed. Colleges in A.P. since the said managements of Pvt. D.El.Ed. Colleges have made admission into the D.El.Ed. Course during academic year 2018-19 on their own in violation of Government orders.
- 3. AND WHEREAS, the matter was considered by SRC in its 386^{th} meeting held on $23^{rd} 24^{th}$ July, 2020 and decided to issue a Show Cause Notice. Accordingly, a Show Cause Notice was issued to the institution on 14.08.2020. The institution has not submitted any reply in response to the Show Cause Notice till date.
- 4. AND WHEREAS, the SRC in its 400th Meeting held on 13th & 14th July, 2021 considered the matter and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

1. The Committee in its 386th meeting after perusal of the letter No. RC.No. 359/A/SCERT/2019 dated 29.6.2020 received from the Commissioner, School Education (FAC), School Education Department, Govt. of Andhra Pradesh recommending therein for derecognition order in respect of 188 Pvt. D.El.Ed. colleges in A.P. since the said managements of Pvt. D.El.Ed. colleges have made admissions into the D.El.Ed. course during academic year 2018-19 on their own in violation of Government orders. Accordingly, the SRC decided to issue a Show Cause Notice to all such institutions asking therein to explain about the observations made by the School Education Department, Govt. of Andhra Pradesh vide letter No. R.C.No. 359/A/SCERT/2019 dated 29.6.2020.

2. In view of the above decision a First Show Cause Notice dated 14.08.2020 was issued to the institution. The institution failed to submit reply to the SCN.

Hence, the Committee decided to withdraw the recognition granted to Penuballi Ramakrishnaiah College of Elementary Education, No. 1, 1st Street, Kodavalur Village, Post & Taluk, Nellore District-524316, Andhra Pradesh for conducting D.El.Ed. programme with effect from the academic session i.e. 2021-2022 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above".
