WHEREAS, the recognition was granted to the institution namely Sri Sai Madhavi College of Education, Plot/Khasra No.464, MGR Nagar Street, Mallampudi Village, Thokada Post Office, Rajanagaram Taluka, Mallampudi Town, East Godavari District-533296, Andhra Pradesh run by Mallidi Narayana Reddy Educational Society, Plot No. 2-210/2, Sri Nagar Street, Anaparthi Village and Post Office, Anaparthi Taluka and Town, East Godavari District-533342, Andhra Pradesh for conducting D.El.Ed & D.El.Ed-Al course following teacher training courses:-

- (i) The SRC vide Order No. SRCAPP1645/D.EI.Ed/AP/2012/46247 dated 18.09.2012 for conducting D.EI.Ed course of two-year duration with an annual intake of 50 students from the academic session 2012-2013.
- (ii) The SRC vide order No. SRO/NCTE/SRCAPP14150/D.EI.Ed-Al/AP/2017-2018/87753 dated 10.08.2016 for conducting D.EI.Ed-Al. Programme of two-year duration with an annual intake of 50 (1 unit) students from the academic session 2017-2018.
- 2. AND WHEREAS, a letter No. RC.No. 359/A/SCERT/2019 dated 29.6.2020 is received from the Commissioner, School Education (FAC), School Education Department, Govt. of Andhra Pradesh on 17.07.2020 recommending therein for derecognition order in respect of 188 Pvt. D.El.Ed. Colleges in A.P. since the said managements of Pvt. D.El.Ed. Colleges have made admission into the D.El.Ed. Course during academic year 2018-19 on their own in violation of Government orders.
- 3. AND WHEREAS, the matter was considered by SRC in its 386^{th} meeting held on $23^{rd}-24^{th}$ July, 2020 and decided to issue a Show Cause Notice. Accordingly, a Show Cause Notice was issued to the institution on 21.08.2020. The institution has not submitted any reply in response to the Show Cause Notice till date.
- **4. AND WHEREAS,** The SRC in its 400th meeting held during 13th 14th July, 2021 considered the matter and decided as under;

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

1. The Committee in its 386th meeting after perusal of the letter No. RC.No. 359/A/SCERT/2019 dated 29.6.2020 received from the Commissioner, School Education (FAC), School Education Department, Govt. of Andhra Pradesh recommending therein for derecognition order in respect of 188 Pvt. D.El.Ed. colleges in A.P. since the said managements of Pvt. D.El.Ed. colleges have made admissions into the D.El.Ed. course during academic year 2018-19 on their own in violation of Government orders. Accordingly, the SRC decided to issue a Show Cause Notice to all such institutions asking therein to explain about the observations made by the School Education Department, Govt. of Andhra Pradesh vide letter No. R.C.No. 359/A/SCERT/2019 dated 29.6.2020.

2. In view of the above decision a First Show Cause Notice dated 21.08.2020 was issued to the institution. The institution failed to submit reply to the SCN.

Hence, the Committee decided to withdraw the recognition granted to Sri Sai Madhavi College of Education, Plot/Khasra No.464, MGR Nagar Street, Mallampudi Village, Thokada Post Office, Rajanagaram Taluka, Mallampudi Town, East Godavari District-533296, Andhra Pradesh for conducting D.El.Ed., D.El.Ed-Al programme with effect from the academic session i.e. 2021-2022 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above."

5. NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of Sri Sai Madhavi College of Education, Plot/Khasra No.464, MGR Nagar Street, Mallampudi Village, Thokada Post Office, Rajanagaram Taluka, Mallampudi Town, East Godavari District-533296, Andhra Pradesh run by Mallidi Narayana Reddy Educational Society, Plot No. 2-210/2, Sri Nagar Street, Anaparthi Village and Post Office, Anaparthi Taluka and Town, East Godavari District-533342, Andhra Pradesh for D.El.Ed. & D.El.Ed-Al Programme with effect from the next academic session i.e. 2021-2022 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website

www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
