WHEREAS, the recognition was granted to the institution namely, Nalanda College of Elementary Education, Plot No. 138/1, M.G. Road, Penamaluru Village & Post, Penamaluru Taluk, Vijayawada City, Krishna District-521139, Andhra Pradesh run by V B M College Committee, Plot No. 138/1, M.G. Road, Penamaluru Village & Post, Penamaluru Taluk, Vijayawada City, Krishna District-521139, Andhra Pradesh vide SRC (NCTE) order No F. SRO/NCTE/SRCAPP15009/D.EI.Ed./AP/2016-2017/82952 dated 03.03.2016 for conducting D.El.Ed. Programme of two-years duration with an annual intake of 50 students (1 one unit) from the academic session 2016-2017.

- AND WHEREAS, the matter was placed before SRC in its 329th Meeting held on 06th & 07th February, 2017 and the Committee decided to Close the file. Accordingly, Rejection order issued on 09.03.2017 for grant of recognition for D.El.Ed programme is hereby rejected.
- AND WHEREAS, thereafter, the institution preferred an appeal u/s 18 of NCTE Act, 1993 and the Appellate Authority vide order No. 89-288/E-1959/2017 Appeal/12th Mtg.2017/25th dated 10.08.2017 granting approval for one unit of D.El.Ed. programme is restored.
- AND WHEREAS, the SRC in its 350th meeting held on 21st & 22nd December, 2017 the order of recognition dated 03.03.2016 granting approval for one unit of D.El.Ed programme is restored. As per vide order No.SRO/NCTE/SRCAPP15009/D.EI.Ed./AP/2017-2018/96428 dated 16.01.2018.
- AND WHEREAS, the management of the institution has submitted a letter on 07.06.2021 for closure of above said institution.
- AND WHEREAS, the SRC in its 400th Meeting held on 13th & 14th July, 2021 considered the 6. matter and decided as under:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee agreed to close down the institution as requested by the management on 20.10.2017 by withdrawing the recognition granted to Nalanda College of Elementary Education, Plot No. 138/1, M.G. Road, Penamaluru Village & Post, Penamaluru Taluk, Vijayawada City, Krishna District-521139, Andhra Pradesh for conducting D.El.Ed. programme under clause 17(1) of NCTE Act, 1993 from the academic session 2021-2022.

However, the FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director on the submission of the following:

(a) NOC from the affiliating body.

(b) NOC from the staff/faculty.

(c) Resolution of the management to the effect for closure of the course"

NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of Nalanda College of Elementary Education, Plot No. 138/1, M.G. Road, Penamaluru Village & Post, Penamaluru Taluk, Vijayawada City, Krishna District-521139, Andhra Pradesh run by V B M College Committee, Plot No. 138/1, M.G. Road, Penamaluru Village & Post, Penamaluru Taluk, Vijayawada City, Krishna District-521139, Andhra Pradesh for D.El.Ed. Programme with effect from the next academic session i.e. 2021-2022 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
