WHEREAS, the recognition was granted to the institution namely Sivaranga College of Education, Plot No.926, Nagalakatta Street, Koilakuntla-518134, Andhra Pradesh vide SRC (NCTE) order no. F.No.APS09574/B.Ed./AP/2011-2012/29550 dated 18.07.2011 for conducting B.Ed. course of one-year duration with an annual intake of 100 students from the academic session 2011-12.

- AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dated 27.01/2015 for its willingness for adherence of provisions of new Regulations.a revised provisional recognition order was issued to the institution on 29.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (Two basic units) from the academic session 2015-16.
- AND WHEREAS, a Corrigendum was issued to the institution vide Order No.F.SRO/NCTE /APS09574/B.Ed./AP/2015/77441 on 31.10.2015 for conducting B.Ed. programme of two years duration with an annual intake of 50 students of one basic unit from the academic session 2015-2016.
- 4. AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the SRC in its 369th meeting held on 28.01.2019 and the committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, Show Cause Notice issued on 03.05.2019. The institution has not reply to Show Cause Notice.
- AND WHEREAS, the SRC in its 381st meeting held on 31st Oct & 01st Nov 2019 considered the 5. matter and decided to issue SCN in all such matters where the institution has not submitted the following requisite documents/VT report not accompanied with the requisite documents in response to RPRO issued by the SRC. Further the Committee also suggested on receiving the reply to the SCN, the SRO may scrutinize the documents and still if there are some deficiency/lapses, the RD is authorized to issue Final SCN and then place the cases before the SRC for its perusal and decision. Accordingly, a Final Show Cause Notice was issued to the institution on 10.12.2019. The institution has submitted reply in response to the Final Show Cause Notice on 30.12.2019.
- AND WHEREAS, the SRC in its 390th Meeting held on 28th & 29th October, 2020 considered the matter and decided as under:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The institution only submitted a letter dt. 26.12.2019 stating that they are running the B.Ed. course with only one unit and following all norms and standards of NCTE Regulations. The committee observed that the institution has written that they are submitting the required documents with this letter but the institution did not submit any document regarding adherence of provisions of NCTE Regulations, 2014 such as land, building plan, NEC, BCC, approval of affiliating body regarding faculty. Further, the committee felt the reluctancy of institution in submission of documents desired under Show Causer Notices.

7. NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of Sivaranga College of Education, Plot No.926, Nagalakatta Street, Koilakuntla-518134, Andhra Pradesh for conducting B.Ed. programme of two year duration with an annual intake of 50 students (1 unit) for B.Ed. course with effect from the academic session i.e. 2021-2022 onwards.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
