#### WITHDRAWAL ORDER

WHEREAS, recognition u/s14(3)(a) of NCTE Act, 1993 was granted to the institution namely, Ahmed College of Elementary Education, Khasara No. 117/118, Plot No.425, Domakonda Street, Rameshwarpally Village and Post, Biknoor Taluk and City, Nizamabad District-503101, Andhra Pradesh, run by Ahmed Educational Society, Plot No. No. 12-2-903, Asif Nagar Street, Hydrabad city & Taluk, Humayun Nagar Post, Hyderabad District-500028, Andhra Pradesh. vide Order No. F.No. SRCAPP672/D.El.Ed /AP/2012/46043 dated 12.09.2012 for conducting D.Ed. Course of two years duration with an annual intake of 50 students from the academic session 2012-13.

- 2. AND WHEREAS, the SRC in its 412<sup>th</sup> meeting held on 05<sup>th</sup> 06<sup>th</sup> July 2022 took note about non-functioning of the website of the institutions which is mandatory requirement as per NCTE Regulations, 2014. In view of the non-compliance, the Regional Committee advised the Regional Director, SRC to issue Show Cause Notice to all such institution seeking infrastructure and instructional details along with GIS location at the earliest. As per decision of SRC, Show Cause Notice was issued to the institution on 03.08.2022. The management of the institution did not submit any reply to the Show Cause Notice.
- 3. AND WHEREAS, the SRC in its 413<sup>th</sup> meeting held on 22<sup>nd</sup> 23<sup>rd</sup> August 2022 discussed the matter in detail about the institutions who failed to submit the PAR as advised by the NCTE. The Regional Director, SRC jurisdictional area serve a Show Cause Notice for failure of submitting the PAR to all such institutions seeking infrastructural & instructional details along with GIS location etc. If any institution failed to respond to Show Cause Notice for compliance, after completion of given time, the RD, SRC may issue Final Show Cause Notice and place before the Committee for appropriate action. Accordingly, as per decision of SRC Final Show Cause Notice was issued to the institution on 08.09.2022. The management of the institution again has not submitted the reply of Final Show Cause Notice.
- 4. AND WHEREAS, the SRC in its 418<sup>th</sup> Meeting of SRC held on 16<sup>th</sup> December 2022 considered the matter for non-submission of reply to Final Show Cause Notice and decided as under: -

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

(i) The institution failed to submit reply to the Final Show Cause Notice dated 08.09.2022.

(ii) Further it is also observed that the institution has not filled Performance
Appraisal Report (PAR)

Hence the recognition granted Ahmed college of Elementary Education, Khasara No. 117/118, Plot No.425, Domakonda Street, Rameshwarpally Village and Post, Biknoor Taluk and City, Nizamabad District-503101, Telangana for D.El.Ed. course is withdrawn under Section 17(1) of NCTE Act, 1993 from the next academic session i.e. 2023-2024. On withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body from the next academic session stands withdrawn.

However, the FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director as per the general resolution taken by the SRC in its earlier meeting.

- 5. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Ahmed college of Elementary Education, Khasara No. 117/118, Plot No.425, Domakonda Street, Rameshwarpally Village and Post, Biknoor Taluk and City, Nizamabad District-503101-Telangana for conducting D.El.Ed. Course (now D.El.Ed. Programme) of two years duration with an annual intake of 50 students (one unit) from the next academic session i.e. 2023-2024.
- 6. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act, 1993: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

(6. इसके अलावा, संस्था और संबद्ध निकाय को एनसीटीई अधिनियम, 1993 की धारा 17(4) के निम्नलिखित प्रावधानों के बारे में सूचित किया जाता है: -

"यदि कोई संस्था उप-धारा (1) के तहत मान्यता वापस लेने के आदेश के लागू होने के बाद शिक्षक शिक्षा में कोई पाठ्यक्रम या प्रशिक्षण प्रदान करती है या जहां कोई संस्थान नियत दिन से ठीक पहले शिक्षक शिक्षा में पाठ्यक्रम या प्रशिक्षण प्रदान करने में विफल रहता है या इस अधिनियम के तहत मान्यता या अनुमति प्राप्त करने हेच्चु उपेक्षा करता है, तो ऐसे पाठ्यक्रम या प्रशिक्षण के अनुसार या ऐसी संस्था में पाठ्यक्रम या प्रशिक्षण लेने के बाद प्राप्त शिक्षक शिक्षा में योग्यता को केंद्र सरकार, किसी राज्य सरकार या विश्वविद्यालय या केन्द्रीय सरकार या किसी राज्य सरकार द्वारा सहायता प्राप्त किसी स्कूल, कॉलेज या अन्य शैक्षिक संस्था में रोजगार के उद्देश्य के लिए वैध योग्यता के रूप में नहीं माना जाएगा।")

- 7. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act,1993 through "online mode" available on NCTE's website <a href="https://www.ncte.gov.in">www.ncte.gov.in</a> within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
