RESTORATION ORDER

WHEREAS, recognition u/s 14 (3)(a) of NCTE Act, 1993 was granted to the institution namely **Smt. Mannaru Yasodamma Memorial B.Ed. College, Addanki Road, Darsi (P.O & M), Kandukur Revenue Division, Prakasam District, Darsi, Andhra Pradesh-523247** vide order no. F.AP/NEW/B.Ed./304/SRO/NCTE/2003-2004/9588 dated 13.10.2003 for conducting B.Ed. programme of one year duration from the academic session 2003-2004 with an annual intake of 100 students.

2. AND WHEREAS, the SRC in its 287th Meeting held on 20th May 2015 permitted shifting to new premises to the institution at **Survey no. 458/1 & 458/3, Addanki Road, 14th Block Darsi Praksam District, Andhra Pradesh-523247** for conducting B.Ed. programme of two years duration with an annual intake of 100 students each for two basic units from the academic session 2015-2016.

3. AND WHEREAS, the matter of the institution was considered by SRC in its 425th Meeting held on 18th May 2023 wherein the SRC decided to issue a Withdrawal Order to the institution for B.Ed. programme. Accordingly, as per decision of SRC Withdrawal Order was issued to the institution vide order no. F.SRC/NCTE/APS01313/B.Ed./AP/2023/142309-142313 dated 06.06.2023.

4. AND WHEREAS, aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority and the Appellate Authority vide order No. 89-15/ E-329848/ 2024/ Appeal/ 8th Meeting, 2024 APPLSRC202314650/ 126060 dated 18.07.2024 remanded back the matter to SRC.

5. AND WHEREAS, as per the decision of SRC in 441st Meeting held on 04th August 2024 Show Cause Notice dated 22.08.2024 was issued to the institution.

6. AND WHEREAS, the reply dated 02.09.2024 in response to SCN was considered by SRC in its 452nd Meeting held on 24th February, 2025 wherein the SRC has decided as under :-

- *As the Appellate Authority vide order dated 18.07.2024 has set aside the withdrawal order and remanded back the case to SRC, the restoration order from 18.07.2024 for B.Ed course be issued to the institution, until a fresh withdrawal order issued by office of SRC.*

7. NOW THEREFORE, as per the direction of Appellate Authority and decision of SRC, the recognition of the institution namely **Smt. Mannur Yasodamma Memorial B.Ed. College Survey no. 458/1 & 458/3, Addanki Road, 14th Block Darsi Praksam District, Andhra Pradesh-523247** run by **Sri Anjani Putra Educational Society, Satram Street, Darsi**

(Village), Darshi (Mandal), Prakasam Distt, Andhra Pradesh for B.Ed. programme for two years duration with an annual intake of 2 basic units (100 students) is hereby restored until fresh withdrawal order is issued by SRC.
