WHEREAS, the recognition u/s 14 (3) (a) of NCTE Act, 1993 was granted to the institution namely K.M.G. College of Education, V. Kaliapuram Post, Vettaikkaran, Pudur Via, Pollachi Taluk, Coimbatore District, Tamilnadu-642129 run by Palaniammal Educational Trust, V.Kaliapuram Post, Pollachi Taluk, Coimbatore District-642129 Tamilnadu vide Order No. F.SRO/NCTE/B.Ed/2006-2007/7111 dated 01.08.2006 for conducting (Secondary) B.Ed. Course of one-year duration with an annual intake of 100 students from the academic session 2005-06.

- AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dated 13.01.2015 for its willingness for adherence of provisions of new Regulations. A Revised Provisional Recognition Order (RPRO) was issued to the institution 01.05.2015 for conducting B.Ed. Programme of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.
- AND WHEREAS, a Corrigendum was No. F.SRO/NCTE/APS03680/B.Ed./TN/2015-2016/57242 dated 16.06.2015 for granted recognition to KMG College of Education Survey No. 208/1B, Angalakurinchi Village & Post, Valparai main Road, Pollachi Taluk, Coimbatore District, Tamilnadu-642007 for conducting B.Ed. programme of two years duration with an annual intake of 50 students (one unit) from the academic session 2015-16.
- AND WHEREAS, the SRC in its 369th meeting held on 28.01.2019 considered the matter and decided to issue a Show Cause Notice to all such institutions which have not submitted compliance in RPRO matter. Accordingly, as per decision of SRC Show Cause Notice was issued to the institution on 07.05.2019. The management of the institution did not submit any reply to Show Cause Notice.
- AND WHEREAS, the SRC in its 405th Meeting held on 13th& 14th December, 2021 the 5. matter was considered and decided to issue Final Show Cause Notice to the institution. Accordingly, as per decision of SRC Final Show Cause Notice was issued to the institution on 13.10.2020. The management of the institution has submitted its reply on 13.01.2022.
- AND WHEREAS, the SRC in its 407th meeting held on 15th February 2022 has considered the matter and decided to Withdraw the Recognition. Accordingly, as per the decision of SRC, a Withdrawal order No.F.SRO/NCTE/APS03680/B.Ed./{TN}/2022/1305 221 was issued to the institution on 28.04.2022.
- AND WHEREAS, aggrieved by the Order of the SRC, the institution preferred an Appeal 7. before the Appellate Authority of the NCTE. The Appellate Authority vide order No. 89-112/E-

251054/2022 Appeal/5<sup>th</sup> Meeting, 2022 Appeal No. APPLSRC202214343 dated 12.07.2022 Appeal Committee of the council concluded that the SRC was justified in withdrawing recognition and therefore the instant appeal deserved to be rejected and the impugned withdrawal order is confirmed.

- **8. AND WHEREAS,** the SRC in its 413<sup>th</sup> meeting held on 22<sup>nd</sup> -23<sup>rd</sup> August 2022 considered the matter and the Committee noted the order of the Appellate Authority confirming the withdrawal order by the SRC, NCTE. Further the office of the Regional Director, SRC is advised to return the FDRs to the institution by following the prescribed rules and close the file and inform the respective affiliating body/ University and the State Govt.
- 9. AND WHEREAS, the institution has filed Writ Petition before Hon'ble High Court of Delhi bearing W.P (C) No. 11638/2022 & CM APPL. 34515-34516/2022. The matter placed before the SRC in its 414<sup>th</sup> Meeting held on 26<sup>th</sup> & 27<sup>th</sup> September 2022 and decided that the institution is entitled to participate in the counselling for the academic session 2022-2023. However, the withdrawal order issued earlier will be effective from the academic session 2023-2024 vide order dated 12.10.2022.
- 10. AND WHEREAS, aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order No. 89-112/E-251054/2022 Appeal/7<sup>th</sup> Meeting, 2022 Appeal No. APPLSRC202214343 dated 19.10.2022 appeal remand back the order appealed against. The institution vide letter dated 22.10.2022 has submitted a reply to the Appeal Remand Back.
- 11. AND WHEREAS, the SRC in its 415<sup>th</sup> meeting held on 03<sup>rd</sup> & 04<sup>th</sup> November 2022 considered the matter and decided as under:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution K.M.G. College of Education, Survey No. 208/1B3A, Angalakurichi Village, Pollachi Taluk, Coimbatore District-642007, Tamilnadu for B.Ed. programme, 1 basic unit of 50 students.

The Committee further decided that the above said decision will be subject to the outcome of writ petition pending before the Hon'ble High Court of Delhi in respect of Performance Appraisal Report (PAR)."

12. NOW THEREFORE, this order is issued permitting the institution i.e. K.M.G. College of Education, Survey No. 208/1B3A, Angalakurichi Village, Pollachi Taluk, Coimbatore District-642007, Tamilnadu run by Palaniammal Educational Trust, V.Kaliapuram Post, Pollachi Taluk, Coimbatore District-642129 Tamilnadu for continuation of recognition for B.Ed. Programme for two-years duration with an annual intake of (1 basic unit) of 50 students

subject to the outcome of writ petition pending before the Hon'ble High Court of Delhi in respect of Performance Appraisal Report (PAR) and fulfilment of the following conditions:-

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- **13.** Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- **14.** The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 15. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
  - a. Sanctioned programme(s) along with annual intake in the institution:
  - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
  - c. Name of faculty members who left of joined during the last, quarter:
  - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
  - e. Fee charged from students;
  - f. Available infrastructural facilities;
  - g. Facilities added during the last quarter;
  - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
  - i. The affidavit with enclosure submitted along with application.
  - j. The institution shall be free to post additional relevant information if it so desires.
  - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

- **16**. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 17. The institution shall make available the list of students admitted on its official website.
- 18. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
